

The City Council of the City of Beloit, Rock County, Wisconsin, do ordain as follows:

Section 1. Territory Annexed. In accordance with Section 66.0217(2) of Wisconsin Statutes and the *Petition for Direct Annexation* filed by Brenda Plakans with the City Clerk on the 28<sup>th</sup> day of April 2025, signed by all of the owners of real property of the following described property in the Town of Turtle, Rock County, Wisconsin, the following territory is annexed to the City of Beloit, Wisconsin:

LOT 102, A RE SUBDIVISION OF OUTLOT A, AND LOTS 34 TO 54, OF TURTLE RIDGE, BEING PART OF THE NORTHEAST 1/4 OF THE SOUTHWEST 1/4 OF SECTION 30, TOWN 1 NORTH, RANGE 13 EAST, OF THE 4TH P.M., TOWN OF TURTLE, ROCK COUNTY, WISCONSIN.

DESCRIBED AS FOLLOWS: BEGINNING AT THE NORTHWEST CORNER OF LOT 102 OF A RE SUBDIVISION OF OUTLOT A, AND LOTS 34 TO 54; THENCE NORTH 65°39'30" EAST ALONG THE NORTH LINE OF AFORESAID LOT 102 A DISTANCE OF 88.34 FEET; THENCE SOUTH 14°19'30" EAST ALONG THE EAST LINE OF AFORESAID LOT 102 A DISTANCE OF 295.86 FEET; THENCE SOUTH 79°40'30" WEST ALONG THE SOUTH LINE OF AFORESAID LOT 102 A DISTANCE OF 96.04 FEET; THENCE NORTH 12°28'53" WEST ALONG THE WEST LINE OF AFORESAID LOT 102 A DISTANCE OF 273.94 FEET TO THE POINT OF BEGINNING. CONTAINING 0.597 ACRES, MORE OR LESS.

Section 2. Effect of Annexation. From and after the date of this Ordinance the territory described in Section 1 shall be part of the City of Beloit for any and all purposes provided by law and all persons coming or residing within such territory shall be subject to all Ordinances, rules, and regulations governing the City of Beloit.

Section 3. Payment to Town of Turtle. The City of Beloit agrees to pay the Town of Turtle, for five (5) years, an amount equal to the annual amount of property taxes levied on the annexed territory by the Town of Turtle as shown on the Town of Turtle's tax roll prepared pursuant to Section 70.65 Wisconsin Statutes.

Section 4. Ward Designation. The territory described in Section 1 of this Ordinance is hereby made a part of the <u>Twenty-first (21st) Ward</u> of the City of Beloit, subject to the Ordinances, rules, and regulations of the City, governing ward districts.

Section 6. Severability. If any provision of this Ordinance is invalid or unconstitutional, or if the application of this to any person or circumstance is invalid or unconstitutional, such invalidity or unconstitutionality shall not affect the other provisions or applications of this Ordinance, which can be given effect without the invalid or unconstitutional provision or application.

Section 7. Effective Date. This Ordinance shall take effect and be in force upon its passage and publication.


