
On February 24, 2025, the City Council adopted attached Ordinance No. 2025-912 annexing approximately 1.56 acres of land along McCann Drive west of North Harmony Townhall Road (see Map 1). The annexation area is undeveloped and contiguous to the city limits along its southern boundary. The applicant proposes to assemble a development site designed to accommodate two-family housing construction on four lots within the annexation area. Development of the land as envisioned would require a conditional use permit to be issued by the Plan Commission. The land area must also be further subdivided in the future to establish individual lots to be served with municipal utilities and public street frontage along McCann Drive. Annexation and zoning of the property as requested are necessary to facilitate the property owner's anticipated development plans for this area. The City Council also adopted the attached Ordinance No. 2025-913 zoning the property to R1, Single-Family and Two-Family Residence District.




