AN ORDINANCE annexing territory owned by the Village to the Village of Hortonville, Wisconsin.

THE VILLAGE BOARD OF THE VILLAGE OF HORTONVILLE DO ORDAIN AS FOLLOWS:

Section 1. Territory Annexed.

In accordance with Wis. Stat. § 66.0223, the following described territory in the Town of Hortonville, Outagamie County, Wisconsin, owned by the Village of Hortonville and lying contiguous to the Village, is hereby annexed to the Village of Hortonville, Wisconsin:

Part of Parcels 2 and 7 of WISDOT Project I.D. 1146-75-21 and part of Parcel 69 of WISDOT Transportation Project Plat No: 1146-75-22-4.28, located in the Southeast Quarter of the Southeast Quarter (SE 1/4 - SE 1/4) of Section 26, Township 22 North, Range 15 East, Town of Hortonville, Outagamie County, Wisconsin, bounded and described as follows:

Commencing at the Southeast corner of said Section 26; thence North 87°07'12" West along the south line of the Southeast Quarter of said Section 26, 33.03 feet to its intersection with the existing west right-of-way line of CTH M and Point of Beginning;

Thence continuing North 87°07'12" West along said south line, 1280.15 feet to the southwest corner of said SE 1/4 - SE 1/4; thence North 00°31'33" East along the west line of said SE 1/4 - SE 1/4, 305.00 feet; thence South 88°58'31" East, 206.57 feet; thence South 83°23'51" East, 381.57 feet; thence South 74°45'09" East, 182.28 feet; thence South 59°04'53" East, 192.61 feet; thence South 76°10'02" East, 178.41 feet; thence South 61°21'53" East, 200.68 feet to said west right-of-way line of CTH M; thence South 00°29'32" West along said existing right-of-way line, 36.01 feet to the Point of Beginning.

Said parcel contains 6.806 Acres (296,481 Square Feet), more or less.

Section 2. Effect of Annexation.

This ordinance shall take effect upon passage and publication, and upon the filing of seven (7) certified copies of this ordinance in the office of the Secretary of the Department of Administration of the State of Wisconsin, together with seven (7) copies of a plat showing the boundaries of the territory attached to the Village. From and after the effective date of this ordinance, the territory described in Section 1 shall be a part of the Village of Hortonville for all purposes provided by law and all persons coming or residing within such territory shall be subject to all ordinances, rules and regulations governing the Village of Hortonville.

Section 3. Severability.

If any provision of this Ordinance is deemed invalid or unconstitutional by a court of law, or if the application of this Ordinance to any person or circumstance is invalid or unconstitutional, such invalidity or unconstitutionality shall not affect the provisions or applications of this Ordinance which can be given effect without the invalid or unconstitutional provision or application.
