AN ORDINANCE TO ANNEX REAL ESTATE LOCATED IN THE TOWN OF WAUPUN TO THE CITY OF WAUPUN, FOND DU LAC COUNTY, WISCONSIN

THE COMMON COUNCIL OF THE CITY OF WAUPUN, DO ORDAIN:

SECTION 1: Real estate described on the attached Exhibit "A," currently owned by Jason R. Engelhardt and Emily J. Engelhardt, is detached from the Township of Waupun and annexed to the City of Waupun, Fond Du Lac County, Wisconsin, all in accordance with Wis.
