ORDINANCE NO. 2025-01

AN ORDINANCE TO ANNEX A PARCEL OF LAND IN SECTION 6, T12N, R12E, FROM THE TOWN OF COURTLAND TO THE VILLAGE OF CAMBRIA, COLUMBIA COUNTY, WISCONSIN

THE VILLAGE BOARD OF THE VILLAGE OF CAMBRIA, COLUMBIA COUNTY, WISCONSIN, ORDAINS AS FOLLOWS:

SECTION I. Petition for Direct Annexation.

A. A petition for Direct Annexation by Unanimous Approval (the "Petition") has been presented to the Village Board of the Village of Cambria praying for the annexation of the following described territory to the Village of Cambria, Columbia County, Wisconsin:

Property Described on Exhibit "A"

- B. The Village Board has reviewed and found the Petition is in compliance with the requirements of Wis. Stat. §66.0217(2).
- C. It is hereby ordered that the above-described property be, and the same hereby is annexed to the Village of Cambria, Wisconsin, from the Town of Courtland, Columbia County, Wisconsin, and it is further ordained that the Village boundaries are amended to include the above-described property within the corporate limits of the Village of Cambria.
- **SECTION II.** Effect of Annexation. From and after the date of this Ordinance, the territory described in the attached Exhibit "A" in Section I shall be a part of the Village of Cambria for any and all purposes provided by law and all persons coming or residing within such territory shall be subject to all ordinances, rules and regulations governing the Village of Cambria.

SECTION III. Zoning.

- A. Pursuant to Wis. Stat. §66.021(7), the territory being annexed to the Village of Cambria by this Ordinance is temporarily assigned the Single- and Multiple-Family Residential District (R-2) zoning district classification and shall be designated as such on the village zoning map.
- B. The Plan Commission is directed to prepare an amendment to the zoning ordinance setting forth permanent classification and regulation for the zoning of the annexed area pursuant to Wis. Stat. §66.23(7)(d).
 - **SECTION IV. Population.** The population of the subject territory is zero (0).
- **SECTION V. Ward Designation.** The territory annexed is hereby made a part of Ward 1 of the Village of Cambria.
 - SECTION VI. Future Taxation. After annexation is effective, the Property described

on Exhibit "A" shall be exempt from further taxation in the Town of Courtland and shall henceforth be subject to taxation and assessments as part of the Village of Cambria.

SECTION VII. Tax Reimbursement. Pursuant to Section 66.0217(14)(a) of the Wisconsin Statutes, the Village of Cambria agrees to pay annually to the Town of Courtland for five (5) years an amount equal to the amount of property taxes that the Town levied on the annexed territory as shown by the tax roll in the year in which the annexation is final.

SECTION VIII. School District. The annexed territory is currently a part of the School District of Cambria-Friesland and the annexation will have no effect on the size or shape of said school district.

SECTION IX. Effective Date. This ordinance shall take effect and be in force from and after its passage and publication.
