**AN ORDINANCE ANNEXING TERRITORY TO THE VILLAGE OF CAMERON PURSUANT TO
WI STAT. § 66.0223**

WHEREAS, the Village of Cameron owns certain property which is not currently located within the Village of Cameron; and

WHEREAS, the Village of Cameron intends to annex such property into the Village of Cameron by this ordinance; and

WHEREAS, Wis. Stat. § 66.0223 specifies the procedure for the annexation of territory owned by the Village.

NOW, THEREFORE, the Board of Trustees of the Village of Cameron, Barron County, Wisconsin, do ordain as follows:

Section One: Pursuant to Wis. Stat. § 66.0223, the Village of Cameron hereby annexes the property which is described in the attached Exhibit A and is shown on the plat attached hereto as Exhibit B (the "Annexed Territory"). No electors reside in the Annexed Territory. Such annexation shall detach the Annexed Territory from the Town of Stanley and attach the same to the Village of Cameron.

Section Two: The Village Clerk is hereby directed to file seven (7) certified copies of this Ordinance and exhibits with the Secretary of Administration. The annexation of the Annexed Territory shall be effective upon such filing.

Section Three: Upon the attachment of the Annexed Territory to the Village, such Annexed Territory shall be in Ward 2, and the Village Clerk shall file with the Barron County Clerk or Board of Election Commissioners the report required by Wis. Stat. § 5.15(4)(b).

Section Four: Within 10 days of filing the certified copies with the Secretary of Administration under Section Two of this Ordinance, the Village Clerk is directed to mail or deliver a copy of the Ordinance and exhibits to the Barron County Clerk.

Section Five: All ordinances or parts of ordinances contravening the terms of this Ordinance are hereby to that extent repealed.


Section Six: This Ordinance shall take effect and be in full force upon its passage and publication as required by law.

Annexed Territory

DESCRIPTION OF AREA TO BE ANNEXED

(From Town of Stanley to Village of Cameron)

A parcel of land which is Outlot 3 of Certified Survey Map #7431, which is a part of the NW 1/4 of the

SE 1/4, and the NE 1/4 of the SE 1/4, of Section 32, T. 34 N., R. 11 W., Town of Stanley, Barron County, Wisconsin, more particularly described as follows:

Beginning at the East 1/4 corner of said Section 32;

thence S 89°31'02"W, 1911.86 feet;

thence S 89°31'02"W, 56.93 feet to the start of a curve concave to the east having a radius of 8479.37 feet, a central angle of 00°14'48", a chord bearing of S 25°49'32"E, and a long chord length of 36.51 feet;

thence southerly along said curve an arc distance of 36.51 feet;

thence N 89°31'02"E, 1953.83 feet;

thence N 01°39'34"W, 33.01 feet to the Point of Beginning.
