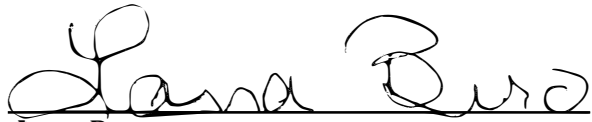

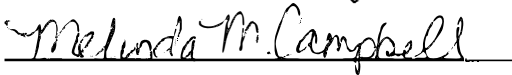

ORDINANCE NUMBER 2560

The Common Council of the City of Marinette do ordain as follows:

Section 1. A Petition has been filed with the Clerk of the City of Marinette requesting the annexation of the hereinafter described territory located in the Town of Peshtigo, Marinette County, Wisconsin to the City of Marinette, Marinette County, Wisconsin by unanimous approval pursuant to Section 66.0217(2), Wis. Stats. The Common Council adopts said Petition for Annexation, thereby ordaining that the following described territory presently in the Town of Peshtigo, Marinette County, Wisconsin, to wit:

SEE EXHIBIT A

Tax Parcel No.: 024-01015.000

And the same is hereby annexed to and made part of the City of Marinette, Marinette County, Wisconsin. Attached hereto, and identified as Exhibit A, is a legal description and scale map of the territory annexed herein. The current population of this territory is zero.

Section 2. All such annexed territory shall be a part of the City of Marinette for any and all purposes provided by law, and shall be subject to the laws, ordinances, rules and regulations of the City of Marinette applicable thereto.

Section 3. That the above-described annexed property prior to annexation was part of the Marinette School District and such territory shall remain part of Marinette School District.

Section 4. The territory is hereby made a part of Ward 5 of the City of Marinette, subject to the ordinances, rules and regulations of the City governing wards.

Section 5. That upon adoption of this Ordinance, the Clerk shall file a certified copy of this Ordinance, a Certificate of Annexation, and a scale map of the property annexed with the Secretary of Administration, with any utility company currently providing service to such area, with the register of Deeds of Marinette County, and with the Marinette School District in accordance with Section 66.0217(9), Wis. Stats., and, further, said Clerk shall give written notice to the Town of Peshtigo.

Section 6. Severability. If any provisions of the ordinance are invalid or unconstitutional, or if the application of this ordinance to any person or circumstance is invalid or unconstitutional, such invalidity or unconstitutionality shall not affect the other provisions or applications of this ordinance which can be given effect without the invalid or unconstitutional provisions or application.

Section 7. Pursuant to Wis. Stats. Section 66.0217(14)(a)(1), the City of Marinette agrees to pay annually to the Town of Peshtigo, for five (5) years, an amount equal to the amount of property taxes

that the Town levied on the annexed territory, as shown by the tax roll under Wis. Stats. Section 70.65,
in the year which the annexation is final.

Section 8. This ordinance shall take effect upon adoption

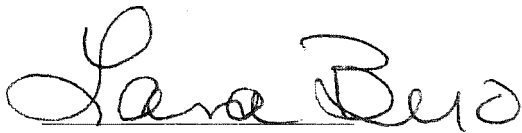
