46 t Alter the Boundaries of Dodge County Supervisory District Nos. 2 and 31 Due to an Annexation (Town of Beaver Dam to City of Beaver Dam)

TO THE HONORABLE BOARD OF SUPERVISORS OF DODGE COUNTY, WISCONSIN,

WHEREAS, on November 9, 2021, the Dodge County Board of Supervisors adopted a 10-year supervisory district plan entitled the *Dodge County – Final Supervisory District Plan*, creating county supervisory districts, municipal aldermanic districts, and election wards following the 2010 Census; and,

WHEREAS, Section 59.10(3)(c), of the *Wisconsin Statutes*, allows a county board, in the exercise of its sole discretion, to alter the boundaries of supervisory districts based on annexations which occur after the adoption of the 10-year supervisory district plan, provided that the number of supervisory districts is not changed; and,

**WHEREAS**, on March 17, 2025, the City of Beaver Dam adopted Ordinance No. 2-2025, annexing a parcel consisting of 3.506 acres, more or less, from the Town of Beaver Dam; and,

WHEREAS, a map of the annexed parcels, the legal descriptions of the parcels and a copy of the annexation ordinances are on file in the Office of the Dodge County Clerk; and,

WHEREAS, the City of Beaver Dam annexed a small parcel along Tower Drive and Kellom Road by the adoption of Ordinance No. 2-2025 consisting of approximately 3.506 acres is appropriately merged with existing City Ward, 24, Aldermanic District 13 in Dodge County Supervisory District 31; and,

WHEREAS, this parcel annexed by the City of Beaver Dam is part of Dodge County Supervisory District No. 2, which consists of Wards 1 and 2 of the Town of Beaver Dam, Ward 4 of the Town of Fox Lake, and Wards 1 and 2 of the Town of Trenton and is appropriately moved into Dodge County Supervisory District No. 31 in the City of Beaver Dam because Dodge County Supervisory District No. 31 consists of Wards 21, 22, 23, 24 25, 27 and 28 of the City of Beaver Dam as the annexed land is adjacent to Supervisory District No. 31; and,

WHEREAS, the Dodge County Executive Committee recommends amending the *Dodge County – Final Supervisory District Plan*, by moving the annexed parcels of land from Dodge County Supervisory District No. 2 to Dodge County Supervisory District No. 31, as shown on the attached documents, entitled *City of Beaver Dam Annexation and Alterations of the Boundaries of Dodge County Supervisory District No. 2 and Dodge County Supervisory District No. 31, 2022 Supervisory District 2* (updated July 2025) and 2022 Supervisory District 31 (updated July 2025), all of which are attached hereto as Exhibit "A" (3 pages); and,

WHEREAS, the population of this small annexed parcel is zero (0) residents which therefore maintains the original population numbers of Dodge County Supervisory District No. 2 and Dodge County Supervisory District No. 31; and,

WHEREAS, the City of Beaver Dam annexation ordinance, legal description of the annexed parcel and associated maps are attached hereto as Exhibit "B" (10 pages);

WHEREAS, this Resolution does not change the number of Dodge County Supervisory Districts;

NOW. THEREFORE, BE IT RESOLVED, that the Dodge County Board of Supervisors hereby amends the Dodge County - Final Supervisory District Plan, by moving the annexed parcel of land from Dodge County Supervisory District No. 2 to Dodge County Supervisory District No. 31, as shown on the attached documents, entitled City of Beaver Dam Annexation and Alterations of the Boundaries of Dodge County Supervisory District No. 2 and Dodge County Supervisory District No. 31, 2022 Supervisory District 2 (updated July 2025) and 2022 Supervisory District 31 (updated July 2025), all of which are attached hereto as Exhibit "A" (3 pages); and,

BE IT FURTHER RESOLVED, that the Dodge County Corporation Counsel is directed to update Section 1.02(1) of the Dodge County Code of Ordinances accordingly in conjunction with the periodic codification process; and,

BE IT FINALLY RESOLVED, that the Chairman of the Dodge County Board of Supervisors shall file a certified copy of this Resolution and attachments, including Exhibit "A", with the Secretary of State of the State of Wisconsin in accordance with the provisions of Section 59.10(3)(c)4., of the Wisconsin Statutes.
