**Village of Belleville, Ward 3, Population 582:** All of the territory within the boundaries of the Village of Belleville and within the County of Green. This territory includes the following newly annexed parcel of land being part of the Southeast Quarter of the Northwest Quarter, the Northeast Quarter of the Southwest Quarter, the Southwest Quarter of the Northeast Quarter and the Northwest Quarter of the Southeast Quarter, all in Section 3, Township 4 North, Range 8 East, and described as follows:
