A CHARTER ORDINANCE to amend Section 6(b) regarding appointment authority with regard to the position of Airport Director.


THE COMMON COUNCIL of the City of La Crosse do ordain as follows:

SECTION I: Section 6(b) is hereby amended to read as follows:


6(b) The ~~Aviation Board~~ Mayor shall appoint the Airport Director from the list of qualified applicants. Such appointment shall be subject to the confirmation of the Common Council with removal for cause by vote of the Common Council.

SECTION II: Any charter provision or any previously enacted ordinance or charter ordinance inconsistent or in conflict herewith is hereby expressly repealed.

SECTION III: This Charter Ordinance shall take effect and be in force sixty (60) days after passage and publication unless within said period a referendum petition shall be filed as provided in Section 66.0101 of the Wisconsin Statutes in which event this ordinance shall not take effect until submission to a referendum vote and approved by a majority of the electors voting thereon.


