

RESOLUTION NO. 24-64

**Resolution to Alter the Boundaries of Dodge County Supervisory District Nos. 19
and 22 Due to an Annexation (Town of Emmet to City of Watertown)**

TO THE HONORABLE BOARD OF SUPERVISORS OF DODGE COUNTY, WISCONSIN,

WHEREAS, on November 9, 2021, the Dodge County Board of Supervisors adopted a 10-year supervisory district plan entitled the *Dodge County – Final Supervisory District Plan*, creating county supervisory districts, municipal aldermanic districts, and election wards following the 2010 Census; and,

WHEREAS, Section 59.10(3)(c), of the *Wisconsin Statutes*, allows a county board, in the exercise of its sole discretion, to alter the boundaries of supervisory districts based on annexations which occur after the adoption of the 10-year supervisory district plan, provided that the number of supervisory districts is not changed; and,

WHEREAS, on September 29, 2024, the City of Watertown completed an annexation of 52.575 acres, more or less, located in the Town of Emmet; and,

WHEREAS, a map of the annexed parcel, and a copy of the annexation ordinance are on file in the Office of the Dodge County Clerk and copies thereof are attached hereto as Exhibit “A” (10 pages); and,

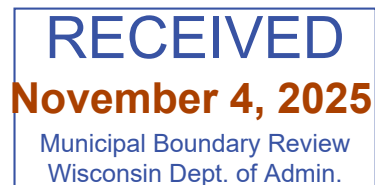
WHEREAS, this parcel annexed by the City of Watertown is part of Dodge County Supervisory District No. 19, which consists of Wards 1 and 2 of the Town of Emmet, and Wards 2 and 3 of the Town of Lebanon; and,

WHEREAS, it is appropriate to create Ward 23 in District 22, as the current population of the annexed property is ten (10) voting residents; and,

WHEREAS, it is appropriate to move the annexed parcel into Dodge County Supervisory District No. 22 in the City of Watertown because Dodge County Supervisory District No. 22 consists of Wards 3, 4, 5 and 23 of the City of Watertown and the annexed land is adjacent to Supervisory District No. 22; and,

NOW, THEREFORE, BE IT RESOLVED, that the Dodge County Board of Supervisors hereby amends the *Dodge County – Final Supervisory District Plan*, by moving the annexed parcel of land from Dodge County Supervisory District No. 19 to Dodge County Supervisory District No. 22, as shown on the attached documents, entitled *An Ordinance for Attachment of Real Estate by Boundary Adjustment from the Town of Emmet to the City of Watertown, Dodge County, Wisconsin*, which has been marked for identification as Exhibit “A” (10 pages); and,

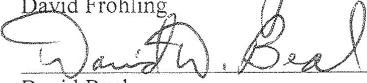
