WHEREAS, the County Board of Supervisors adopted Resolution 04-02-25 on February 18, 2025 relating to tax parcel 008-00214-0100 that was annexed into the City of Wautoma, by way of City of Wautoma Ordinance 2024-01 filed with the Register of Deeds December 20, 2024, as Document Number 551554; and

WHEREAS, Resolution added tax parcel 008-00214-0100 to District 8, Ward 3, and

WHEREAS, it has been determined that it was a clerical error and that the annexed property should have been added to District 8, Ward 2 instead of Ward 3.

NOW THEREFORE, the County Board does hereby resolve to amend Resolution 04-02-25 to amend County Board Supervisory District 8, City of Wautoma Ward 2 to include parcel 008-00214-0100 annexed into the City of Wautoma.

BE IT FURTHER RESOLVED that pursuant to Wisconsin Statutes Section 59.10(3)(c)(3), said modification shall be effective November 15, 2025.

BE IT FURTHER RESOLVED that the County Clerk shall send a copy of this resolution to the Secretary of State pursuant to Wisconsin Statutes 59.10(3)(c)(4).







RESOLUTION NO. 04-02-25
A RESOLUTION PURSUANT TO WISCONSIN STATUTES SECTION 59.10(3)(c)(3)
TO MODIFY COUNTY BOARD SUPERVISOR DISTRICT 8, CITY OF WAUTOMA WARD 3
TO INCLUDE NEWLY ANNEXED PROPERTY

WHEREAS, tax parcel 008-00214-0100 was annexed into the City of Wautoma, by way of City of Wautoma Ordinance 2024-01 filed with the Register of Deeds December 20, 2024, as Document Number 551554; and

WHEREAS, the annexation changes the property from Town of Dakota to the City of Wautoma, necessitating a change in the categorization of said property as it relates to ballot preparation and election districts; and

WHEREAS, Wisconsin Statute Section 59.10(3)(c), the County Board may amend a supervisory district plan to reflect a municipal incorporation, annexation, detachment or consolidation; and

WHEREAS, failure to amend the supervisory district would result in the creation of a new ward, which would increase election costs related to ballots and procedures.

NOW THEREFORE, the County Board does hereby resolve to amend County Board Supervisory District 8, City of Wautoma Ward 3 to include parcel 008-00214-0100 annexed into the City of Wautoma.

BE IT FURTHER RESOLVED that pursuant to Wisconsin Statutes Section 59.10(3)(c)(3), said modification shall be effective November 15, 2025.

BE IT FURTHER RESOLVED that the County Clerk shall send a copy of this resolution to the Secretary of State pursuant to Wisconsin Statutes 59.10(3)(c)(4).


