A CHARTER ORDINANCE TO CONSOLIDATE THE OFFICES OF CLERK AND TREAURER

The Village Board of the Village of Rosholt do ordain as follows:

<u>Section 1:</u> Pursuant to Wis. Stat. §§ 66.0101 & 61.195, following the effective date of this Charter Ordinance, the respective Village Offices of Clerk and Treasurer shall be consolidated into one position, the Office of Clerk-Treasurer.

<u>Section 2:</u> The position of Clerk-Treasurer shall be filled by Village Board appointment for a term in the same manner as was established for the positions of Clerk and Treasurer in the Village's respective charter ordinances enacted in 1996.

<u>Section 3:</u> The Village Clerk-Treasurer shall perform all duties required by Wisconsin law, Village ordinances, and/or other direction of the Village Board.

Section 4: All ordinances and/or parts of ordinances in conflict herewith are hereby repealed.

<u>Section 5</u>: This Charter Ordinance shall be in full force and effect from and after sixty (60) days after its date of adoption by a 2/3 majority of the members-elect of the Village Board, and notice to the public as required by law, unless within such sixty (60) days a referendum petition is filed as provided by Wis. Stat. § 66.0101(5), in which event this Charter Ordinance shall not take effect until submitted to a referendum and approved by a majority of the electors voting thereon.

<u>Section 6</u>: Village personnel are hereby authorized and directed to take all necessary steps to notice this Charter Ordinance to the public and, upon enactment, to file a certified copy with the Wisconsin Secretary of State.

A CHARTER ORDINANCE

RELATING TO THE SELECTION AND TENURE OF THE VILLAGE ASSESSOR

The Village Board of the Village of Rosholt do ordain as follows:

Section 1. Pursuant to sections 61.195, 61.197 and 66.01 of the Wisconsin statutes, the Village of Rosholt hereby elects not to be governed by thos portions of section 61.19 and 61.23 of the statutes which relate to the selection and tenure of the Village Assessor and which are in conflict with this ordinance.

Section 2. Hereafter, instead of being elected, the assessor of the Village of Roshelt shall be appointed by vote of a majority of the members-elect of the Village Board.

Section 1. The term of said assessor shall be for two (2) years and until his successors are selected and qualify. Such term shall begin on the 15th day of April succeeding his election.

Section 4. This ordinance shall not in way affect the right of any person whose term of office has begun but not expired on the effective date of this ordinance, to complete his term of office.

Section 5. This is a charter ordinance and shall take effect sixty (60) days after its passage and publication, unless within such sixty(60) days a referendum petition shall be filed as provided by section 66.01 of the Wisconsin statutes, in which event this ordinance shall not take effect until submitted to a referendum and approved by a majority of the wheeters voting thereon.
