4 **and 15 Due to an Annexation**
5 **(Town of Theresa to Village of Theresa)**

7 TO THE HONORABLE BOARD OF SUPERVISORS OF DODGE COUNTY, WISCONSIN,

9 **WHEREAS**, on November 9, 2021, the Dodge County Board of Supervisors adopted a 10-
10 year supervisory district plan entitled the *Dodge County – Final Supervisory District Plan*, creating
11 county supervisory districts, municipal aldermanic districts, and election wards following the 2010
12 Census; and,

13
14 **WHEREAS**, Section 59.10(3)(c), of the *Wisconsin Statutes*, allows a county board, in the
15 exercise of its sole discretion, to alter the boundaries of supervisory districts based on annexations
16 which occur after the adoption of the 10-year supervisory district plan, provided that the number
17 of supervisory districts is not changed; and,

18
19 **WHEREAS**, on October 20, 2025, the Village of Theresa adopted Ordinance No. 2025-
20 03, annexing a parcel consisting of approximately 0.445 acres, more or less, the parcel being a part
21 of Parcel Identification No. 042-1217-1512-002, (hereafter “the parcel”) from the Town of
22 Theresa; and,

24 **WHEREAS**, on November 3, 2025, the Town of Theresa adopted an *Ordinance for the*
25 *Detachment of Territory from the Town of Theresa*, detaching the aforementioned parcel from the
26 Town, confirming compliance with Sec. 66.0227, Wis. Stats., for the annexation of the parcel to
27 the Village of Theresa; and,

29 **WHEREAS**, a map of the annexed parcel, the legal description of the parcel and a copy of
30 the annexation/detachment ordinances are on file in the Office of the Dodge County Clerk; and,

32 **WHEREAS**, the parcel annexed by the Village of Theresa was a part of Dodge County
33 Supervisory District No. 15, consisting of Ward 2 of the Town of LeRoy; Wards 1, 2 and 3 of the
34 Town of Lomira; Wards 2 and 4 of the Town of Theresa and Village of Brownsville, and is
35 appropriately moved into Dodge County Supervisory District No. 12, Village of Theresa, Ward 3
36 because the annexed land is adjacent to Supervisory District No. 12, Village of Theresa, Ward 3;
37 and,

39 **WHEREAS**, the Dodge County Executive Committee recommends amending the *Dodge*
40 *County – Final Supervisory District Plan*, by moving the annexed parcel of land from Dodge County
41 Supervisory District No. 15 to Dodge County Supervisory District No. 12, as shown on the attached
42 document entitled *Village of Theresa Annexation and Alternations of the Boundaries of Dodge*
43 *County Supervisory District No. 12 and Dodge County Supervisory District No. 15*, attached hereto
44 as Exhibit “A”; and,

1 **WHEREAS**, the population of the parcel is zero (0) residents which therefore maintains
2 the original population numbers of Dodge County Supervisory District No. 15 and Dodge County
3 Supervisory District No. 12; and,

5 **WHEREAS**, this Resolution does not change the number of Dodge County Supervisory
6 Districts;

8 **NOW, THEREFORE, BE IT RESOLVED**, that the Dodge County Board of Supervisors
9 hereby amends the *Dodge County – Final Supervisory District Plan*, by moving the annexed parcel
10 of land from Dodge County Supervisory District No. 15 to Dodge County Supervisory District No.
11 12, as shown on the attached document entitled *Village of Theresa Annexation and Alternations of*
12 *the Boundaries of Dodge County Supervisory District No. 12 and Dodge County Supervisory District*
13 *No. 15*, attached hereto as Exhibit “A”; and,

15 **BE IT FURTHER RESOLVED**, that the Dodge County Corporation Counsel is directed
16 to update Section 1.02(1) of the *Dodge County Code of Ordinances* accordingly in conjunction
17 with the periodic codification process; and,

19 **BE IT FINALLY RESOLVED**, that the Chairman of the Dodge County Board of
20 Supervisors shall file a certified copy of this Resolution and Exhibit “A”, with the Secretary of
21 State of the State of Wisconsin in accordance with the provisions of Section 59.10(3)(c)4., of the
22 *Wisconsin Statutes*.

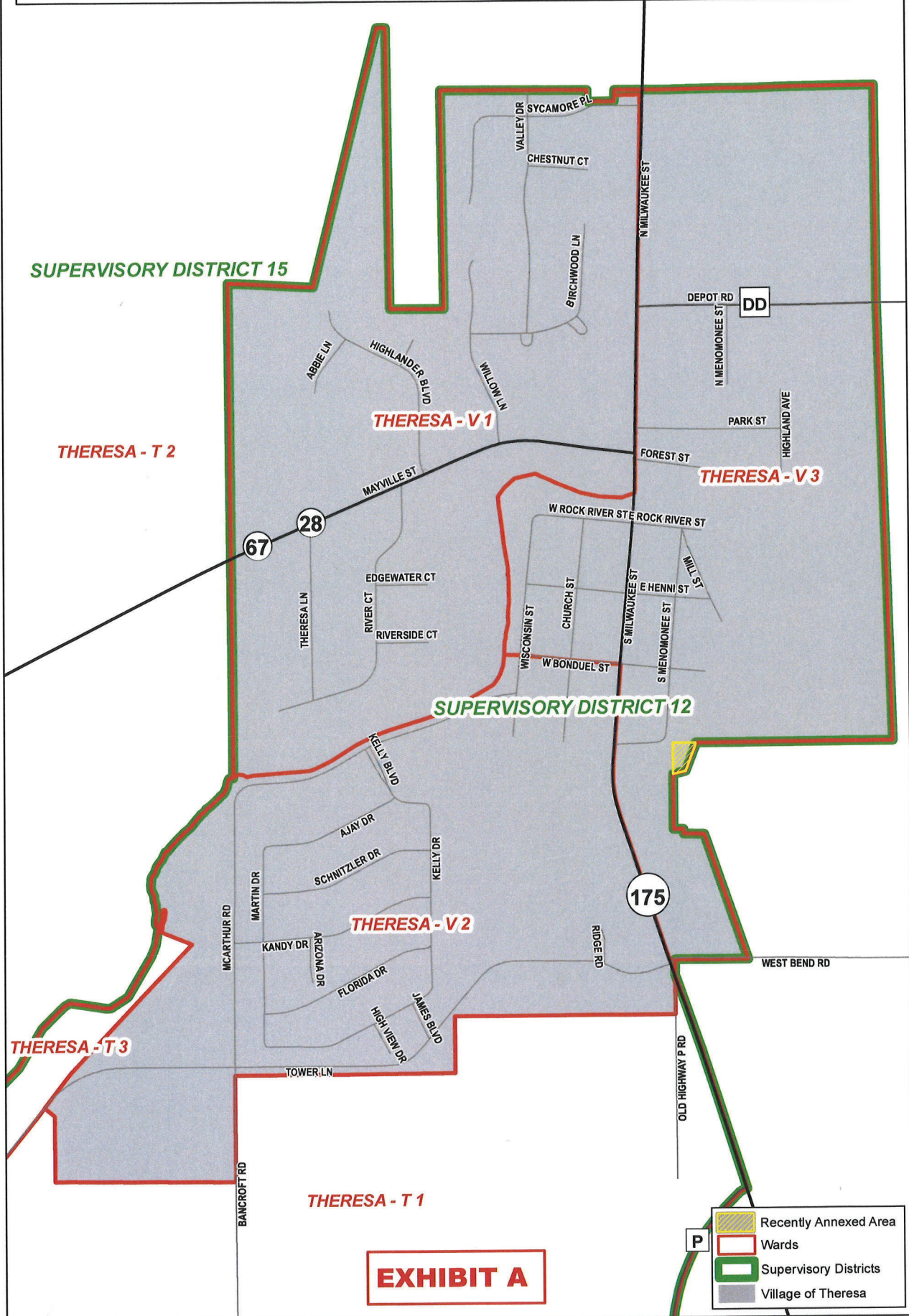
