4 **and 31 Due to an Annexation (Town of Beaver Dam to City of Beaver Dam)**

5 TO THE HONORABLE BOARD OF SUPERVISORS OF DODGE COUNTY, WISCONSIN,

8 **WHEREAS**, on November 9, 2021, the Dodge County Board of Supervisors adopted a 10-
9 year supervisory district plan entitled the *Dodge County – Final Supervisory District Plan*, creating
10 county supervisory districts, municipal aldermanic districts, and election wards following the 2010
11 Census; and,12
13 **WHEREAS**, Section 59.10(3)(c), of the *Wisconsin Statutes*, allows a county board, in the
14 exercise of its sole discretion, to alter the boundaries of supervisory districts based on annexations
15 which occur after the adoption of the 10-year supervisory district plan, provided that the number
16 of supervisory districts is not changed; and,17
18 **WHEREAS**, on March 18, 2024, the City of Beaver Dam completed an annexation of
19 10.952 acres, more or less, located in the Town of Beaver Dam; and,20
21 **WHEREAS**, a map of the annexed parcel, and a copy of the annexation ordinance are on
22 file in the Office of the Dodge County Clerk and copies thereof are attached hereto as Exhibit "A"
23 (6 pages); and,24
25 **WHEREAS**, this parcel annexed by the City of Beaver Dam is part of Dodge County
26 Supervisory District No. 2, which consists of Wards 1 and 2 of the Town of Beaver Dam, Ward 4
27 of the Town of Fox Lake, and Wards 1 and 2 of the Town of Trenton; and,28
29 **WHEREAS**, it is appropriate to move the annexed parcel into Dodge County Supervisory
30 District No. 31 in the City of Beaver Dam because Dodge County Supervisory District No. 31
31 consists of Wards 21, 22, 23, 24 and 25 of the City of Beaver Dam; and,32
33 **WHEREAS**, the population of the annexed parcels is zero (0) residents which, therefore,
34 maintains the original population numbers of Dodge County Supervisory District No. 2 and Dodge
35 County Supervisory District No. 31; and,36
37 **WHEREAS**, this Resolution does not change the number of Dodge County Supervisory
38 Districts;39
40 **NOW, THEREFORE, BE IT RESOLVED**, that the Dodge County Board of Supervisors
41 hereby amends the *Dodge County – Final Supervisory District Plan*, by moving the annexed parcel
42 of land from Dodge County Supervisory District No. 2 to Dodge County Supervisory District No.
43 31, as shown on the attached documents, entitled *City of Beaver Dam Annexations and Alterations*
44 *of the Boundaries of Dodge County Supervisory District No. 2 and Dodge County Supervisory*
45 *District No. 31*, which has been marked for identification as Exhibit "A" (6 pages); and,





ORDINANCE NO. 3-2024

AN ORDINANCE ANNEXING CONTIGUOUS TERRITORY TO THE CITY OF
BEAVER DAM PURSUANT TO WIS. STATS. SEC. 66.0217(2) (ANNEXATION
BY UNANIMOUS APPROVAL)

THE COMMON COUNCIL OF THE CITY OF BEAVER DAM DO
ORDAIN AS FOLLOWS:

SECTION I: Section 1-14 of the Municipal Code is hereby amended by annexing the territory as described and shown on the documents attached hereto and made a part hereof:

Direct annexation from the Town of Beaver Dam to the City of Beaver Dam of 7.474 acres of land being Tax Parcel No. 004-1214-2234-001, being Lot 1 of Certified Survey Map No. 4953, recorded August 6, 2001, as Document No. 936116, in Vol. 32 of CSMs, Pages 50-51, Town of Beaver Dam, Dodge County, Wisconsin, and the adjoining 3.478 acres of land being the Kellom Road right-of-way.

Said parcel being located on Kellom Road, and as petitioned by JCW Kellom LLC.

SECTION II: Said parcel, upon its annexation, creates new Ward 27 in the City of Beaver Dam.

SECTION III: There are no residents living on the property to be annexed.

SECTION IV: Said parcel, upon its annexation, is hereby zoned Commercial District pursuant to Sec. 70-88 of the Municipal Code.



Annexation Boundary - Legal Description

Being all of Lot 1 of Certified Survey Map No. 4953, as recorded in Volume 32 of Certified Survey Maps, Page 50 as Document No. 936116, a part of the Southeast 1/4 of the Southwest 1/4 and a part of the Southwest 1/4 of the Southeast 1/4 of Section 22, Township 12 North, Range 14 East, Town of Beaver Dam, Dodge County, Wisconsin, being more particularly described as follows:

Commencing at the South 1/4 corner of Section 22, Township 12 North, Range 14 East; Thence S 89°22'57" W along the South line of the Southwest 1/4 of said Section 22, 746.44 feet; Thence N 00°47'46" W, 54.73 feet to the Point of Beginning (POB) of the Annexation Boundary to be described; Thence N 59°17'02" W, 96.53 feet to the westerly right-of-way line of Kellom Road; Thence N 22°21'56" E along said westerly right-of-way line of Kellom Road, 92.02 feet; Thence N 38°35'46" E along said westerly right-of-way line of Kellom Road, 17.24 feet to the most southerly corner of Lot 1 of Certified Survey Map No. 4953; Thence N 04°08'06" E along the West line of said Lot 1, 799.54 feet to the Northwest corner thereof; Thence N 89°27'01" E along the North line of said Lot 1, 675.91 feet to the Northeast corner thereof, said point also being on the westerly right-of-way line of Kellom Road; Thence N 20°22'16" E along said westerly right-of-way line of Kellom Road, 334.80 feet to the intersection of said westerly right-of-way line of Kellom Road and the North line of the Southwest 1/4 of the Southeast 1/4 of said Section 22; Thence N 89°43'54" E along said North line, 97.46 feet; Thence S 19°47'28" W, 392.34 feet; Thence southwesterly 690.01 feet along the arc of a curve, concave northwesterly, having a radius of 1178.82 feet and whose long chord bears S 36°33'30" W, 680.21 feet; Thence S 53°19'33" W, 350.66 feet; Thence southwesterly 171.63 feet along the arc of a curve, concave southeasterly, having a radius of 239.84 feet and whose long chord bears S 32°49'33" W, 167.99 feet to the Point of Beginning.
