3 **Alter the Boundaries of Dodge County Supervisory District Nos. 2**
4 **and 31 Due to an Annexation**
5 **(Town of Beaver Dam to City of Beaver Dam)**

7 TO THE HONORABLE BOARD OF SUPERVISORS OF DODGE COUNTY, WISCONSIN,

8

9 **WHEREAS**, on November 9, 2021, the Dodge County Board of Supervisors adopted a 10-
10 year supervisory district plan entitled the *Dodge County – Final Supervisory District Plan*, creating
11 county supervisory districts, municipal aldermanic districts, and election wards following the 2010
12 Census; and,

13 **WHEREAS**, Section 59.10(3)(c), of the *Wisconsin Statutes*, allows a county board, in the
14 exercise of its sole discretion, to alter the boundaries of supervisory districts based on annexations
15 which occur after the adoption of the 10-year supervisory district plan, provided that the number
16 of supervisory districts is not changed; and,

17 **WHEREAS**, on March 17, 2025, the City of Beaver Dam adopted Ordinance No. 2-2025,
18 annexing a parcel consisting of 3.506 acres, more or less, from the Town of Beaver Dam; and,

19 **WHEREAS**, a map of the annexed parcels, the legal descriptions of the parcels and a copy
20 of the annexation ordinances are on file in the Office of the Dodge County Clerk; and,

21 **WHEREAS**, the City of Beaver Dam annexed a small parcel along Tower Drive and
22 Kellom Road by the adoption of Ordinance No. 2-2025 consisting of approximately 3.506 acres is
23 appropriately merged with existing City Ward, 24, Aldermanic District 13 in Dodge County
24 Supervisory District 31; and,

25 **WHEREAS**, this parcel annexed by the City of Beaver Dam is part of Dodge County
26 Supervisory District No. 2, which consists of Wards 1 and 2 of the Town of Beaver Dam, Ward 4
27 of the Town of Fox Lake, and Wards 1 and 2 of the Town of Trenton and is appropriately moved
28 into Dodge County Supervisory District No. 31 in the City of Beaver Dam because Dodge County
29 Supervisory District No. 31 consists of Wards 21, 22, 23, 24 25, 27 and 28 of the City of Beaver
30 Dam as the annexed land is adjacent to Supervisory District No. 31; and,

31 **WHEREAS**, the Dodge County Executive Committee recommends amending the *Dodge*
32 *County – Final Supervisory District Plan*, by moving the annexed parcels of land from Dodge
33 County Supervisory District No. 2 to Dodge County Supervisory District No. 31, as shown on the
34 attached documents, entitled *City of Beaver Dam Annexation and Alterations of the Boundaries of*
35 *Dodge County Supervisory District No. 2 and Dodge County Supervisory District No. 31, 2022*
36 *Supervisory District 2* (updated July 2025) and *2022 Supervisory District 31* (updated July 2025),
37 all of which are attached hereto as Exhibit “A” (3 pages); and,

38 **WHEREAS**, the population of this small annexed parcel is zero (0) residents which
39 therefore maintains the original population numbers of Dodge County Supervisory District No. 2
40 and Dodge County Supervisory District No. 31; and,

2 **WHEREAS**, the City of Beaver Dam annexation ordinance, legal description of the
3 annexed parcel and associated maps are attached hereto as Exhibit "B" (10 pages);

5 **WHEREAS**, this Resolution does not change the number of Dodge County Supervisory
6 Districts;

8 **NOW, THEREFORE, BE IT RESOLVED**, that the Dodge County Board of Supervisors
9 hereby amends the *Dodge County – Final Supervisory District Plan*, by moving the annexed parcel
10 of land from Dodge County Supervisory District No. 2 to Dodge County Supervisory District No.
11 31, as shown on the attached documents, entitled *City of Beaver Dam Annexation and Alterations*
12 of the *Boundaries of Dodge County Supervisory District No. 2 and Dodge County Supervisory*
13 *District No. 31, 2022 Supervisory District 2* (updated July 2025) and *2022 Supervisory District 31*
14 (updated July 2025), all of which are attached hereto as Exhibit "A" (3 pages); and,


16 **BE IT FURTHER RESOLVED**, that the Dodge County Corporation Counsel is directed
17 to update Section 1.02(1) of the *Dodge County Code of Ordinances* accordingly in conjunction
18 with the periodic codification process; and,

20 **BE IT FINALLY RESOLVED**, that the Chairman of the Dodge County Board of
21 Supervisors shall file a certified copy of this Resolution and attachments, including Exhibit "A",
22 with the Secretary of State of the State of Wisconsin in accordance with the provisions of Section
23 59.10(3)(c)4., of the *Wisconsin Statutes*.







ORDINANCE NO. 2-2025

**AN ORDINANCE PROVIDING FOR THE DIRECT ANNEXATION OF PROPERTY IN
THE TOWN OF BEAVER DAM TO THE CITY OF
BEAVER DAM, DODGE COUNTY, WISCONSIN**

RECITALS

- A. On February 3, 2025, a petition to annex (the "Annexation Petition") the property described in and depicted on Exhibit A (the "Property") to the City of Beaver Dam was filed with the City. The Annexation Petition was signed by all property owners of the real property described in the Annexation Petition and is incorporated as Exhibit B.
- B. The current population of the Property is zero (0).
- C. A copy of the Annexation Petition, together with a scale map and a legal description of the Property, was filed with the Wisconsin Department of Administration and the Town Clerk of the Town of Beaver Dam.
- D. The City has considered the recommendations, if any, that the Department of Administration has made regarding the annexation.
- E. The City has determined that annexing the Property is in the public interest and that the annexation complies with Wisconsin law.

NOW THEREFORE, the City Council of the City of Beaver Dam, Dodge County, do ordain as follows:

ORDINANCE

1. **Property Annexed.** In accordance with Wis. Stat. § 66.0217, the City Council of the City of Beaver Dam annexes the Property.
2. **Effect of Annexation.** From and after the effective date, the Property shall be a part of the City of Beaver Dam for any and all purposes provided by law, and all persons coming or residing within such Property shall be subject to all ordinances, rules, and regulations governing the City of Beaver Dam.
3. **Ward Designation.** From and after the effective date, the Property annexed by this Ordinance shall be incorporated into Ward No. 24, District 13 of the City.
4. **Clerk Duties.** From and after the effective date, the City Clerk is hereby directed to provide notice and copies of this Ordinance pursuant to the applicable Wisconsin statutes.
5. **Zoning.** From and after the effective date, the Property shall be zoned in the light manufacturing zoning district.
6. **Payment to Town of Beaver Dam.** Pursuant to Wis. Stat. § 66.0217(14)(a)1., the City agrees to pay annually to the Town of Beaver Dam, for five (5) years, an amount equal to the amount of property taxes that the Town of Beaver Dam levied on the Property as shown by the Town's 2024 tax roll.
7. **Effective Date.** This Ordinance shall take effect after publication in accordance with Wisconsin law.



The undersigned requests that this annexation be approved and take effect in the manner provided for by law.




