TO: THE HONORABLE CHAIR AND MEMBERS OF THE PORTAGE COUNTY BOARD **SDR154**  
OF SUPERVISORS:

RE: AMENDING SUPERVISORY DISTRICT BOUNDARIES RESULTING FROM THE  
VILLAGE OF PLOVER'S ANNEXATION

WHEREAS, Wis. Stat. § 59.10(3)(c) provides authority for the County Board to amend the boundaries of supervisory districts based on municipal annexations which occur after passage of the 10-year supervisory district plan; and

WHEREAS, after the 10-year plan, in July of 2025, the Village of Plover duly annexed property from the Town of Plover, the legal description of which is as follows:

PART OF THE EAST 1/2 OF THE SW 1/4 OF SECTION 11, TOWNSHIP 23 NORTH, RANGE 8 EAST, TOWN OF PLOVER, PORTAGE COUNTY, WISCONSIN, DESCRIBED AS FOLLOWS:

COMMENCING AT THE WEST 1/4 CORNER OF SAID SECTION 11; THENCE EAST ALONG THE EAST-WEST 1/4 LINE OF SAID SECTION 11 TO THE 1/16 CORNER AND THE POINT OF BEGINNING; THENCE EAST ALONG EAST-WEST 1/4 LINE OF SAID SECTION 11 ALSO BEING THE SOUTH LINE OF OAKWOOD FOREST 1982, PARADISE SOUTH AND PARADISE EAST SUBDIVISIONS TO THE WEST LINE OF INSTATE HIGHWAY "39"; THENCE SOUTH ALONG THE WEST LINE OF INSTATE HIGHWAY "39" TO THE NORTH LINE OF PORTER ROAD; THENCE SOUTHWESTERLY ALONG THE NORTH LINE OF PORTER ROAD TO THE EAST LINE OF CERTIFIED SURVEY MAP NUMBER 639, VOLUME 2, PAGE 299; THENCE NORTH ALONG THE EAST LINE OF SAID CERTIFIED SURVEY MAP NUMBER 639 TO THE NORTH LINE OF SAID CERTIFIED SURVEY MAP NUMBER 639; THENCE ALONG THE NORTH LINE OF SAID CERTIFIED SURVEY MAP NUMBER 639 TO THE NORTHEAST CORNER OF CERTIFIED SURVEY MAP NUMBER 4213, VOLUME 15, PAGE 8 & 8A; THENCE ALONG THE NORTH LINE OF SAID CERTIFIED SURVEY MAP NUMBER 4213 TO THE WEST LINE OF SAID CERTIFIED SURVEY MAP NUMBER 4213; THENCE SOUTH ALONG THE WEST LINE OF SAID CERTIFIED SURVEY MAP NUMBER 4213 TO THE NORTH LINE OF PORTER ROAD; THENCE WEST ALONG THE NORTH LINE OF PORTER ROAD TO A POINT 230 FEET EAST OF THE WEST LINE OF THE EAST 1/2 OF THE SOUTHWEST 1/4; THENCE NORTH PARALLEL TO THE WEST LINE OF THE EAST 1/2 OF THE WEST 1/4 284.15 FEET TO AN IRON PIPE; THENCE WEST TO THE WEST LINE OF THE EAST 1/2 OF THE SOUTHWEST 1/4 ALSO BEING THE EAST LINE OF SCOTCHWOOD SUBDIVISION; THENCE NORTH ALONG THE WEST LINE OF THE EAST 1/2 OF THE SOUTHWEST 1/4 ALSO BEING THE EAST LINE OF THE SCOTCHWOOD, HIGHLAND ESTATES AND BRENTWOOD ESTATES SUBDIVISION TO THE POINT OF BEGINNING

which property should be included in Supervisory District #17, and there are no electors residing within the property; and

WHEREAS, the number of supervisory districts in Portage County was not changed by the Village of Plover's annexation; and

WHEREAS, a scale map of the above-described parcel, along with a certified copy of the Village of Plover Annexation Ordinance, have been duly filed with the Clerk of Portage County.

FISCAL NOTE: There are no fiscal obligations for the county associated with this resolution.

NOW, THEREFORE, BE IT RESOLVED that the Portage County Board of Supervisors hereby approves amending the supervisory district enumerated above to include the above-described duly annexed property, now within the Village of Plover.

BE IT FURTHER RESOLVED that the Portage County Clerk is hereby directed to file all notices of the amended plan required under Wis. Stat. Ch. 59 with the Secretary of State.
