RESOLUTION APPROVING ALTERATION OF SUPERVISORY  
DISTRICT BOUNDARY – VILLAGE OF BALDWIN (FROM TOWN OF  
RUSH RIVER)**

1 **WHEREAS**, in 2021, the St. Croix County Board of Supervisors adopted a 10-year  
2 supervisory district plan creating county supervisory districts, municipal aldermanic districts and  
3 election wards following the 2020 Census; and  
4

5 **WHEREAS**, Wis. Stat. § 59.10(3)(c) allows a county board, in its discretion, to alter the  
6 boundaries of supervisory districts based on annexations which occur after the adoption of the  
7 10-year supervisory district plan, as long as the number of supervisory districts is not changed;  
8 and

10 **WHEREAS**, the Village of Baldwin completed an annexation from the Town of Rush  
11 River on April 10, 2024 of a parcel described on the attached Ordinance #2024-01 consisting of  
12 42.19 acres; and  
13

14 **WHEREAS**, a map of the annexed parcel, along with a copy of the annexation ordinance  
15 has been filed with the St. Croix County Clerk and is attached; and  
16

17 **WHEREAS**, the parcel annexed by the Village of Baldwin was part of County  
18 Supervisor District 16, consisting of Ward 1, in the Town of Rush River; and  
19

20 **WHEREAS**, it is appropriate to move the annexed parcel into County Supervisor District  
21 18, Ward 6, in the Village of Baldwin; and  
22

23 **WHEREAS**, the parcel annexed by the Village of Baldwin and made part of Ward 6  
24 does not cross an assembly district or congressional district line; and  
25

26 **WHEREAS**, the population of the annexed parcel is three; and  
27

28 **WHEREAS**, this resolution does not change the number of supervisory districts.  
29

30 **NOW, THEREFORE, BE IT RESOLVED** by the St. Croix County Board of  
31 Supervisors that the supervisory district boundary is hereby altered by moving the annexed  
32 parcel of land from County Supervisor District 16 to County Supervisor District 18 consisting of  
33 Ward 6 in the Village of Baldwin as shown on the attached.

35 **BE IT FURTHER RESOLVED** that the St. Croix County Clerk is hereby directed to  
36 forward all notices required under Chapter 59 of Wisconsin Statutes to the Secretary of State for  
37 the purpose of advising that office of said supervisory district boundary changes.


