RESOLUTION APPROVING ALTERATION OF SUPERVISORY DISTRICT BOUNDARIES – CITY OF NEW RICHMOND (FROM TOWN OF RICHMOND)

1 **WHEREAS**, in 2021, the St. Croix County Board of Supervisors adopted a 10-year
2 supervisory district plan creating county supervisory districts, municipal aldermanic districts and
3 election wards following the 2020 Census; and
4

5 **WHEREAS**, Wis. Stat. § 59.10(3)(c) allows a county board, in its discretion, to alter the
6 boundaries of supervisory districts based on annexations which occur after the adoption of the
7 10-year supervisory district plan, as long as the number of supervisory districts is not changed;
8 and
9

10 **WHEREAS**, the City of New Richmond completed an annexation from the Town of
11 Richmond on May 13, 2024 of parcel described on the attached Ordinance #606 consisting of
12 2.104 acres; and
13

14 **WHEREAS**, the City of New Richmond completed an annexation from the Town of
15 Richmond on October 14, 2024 of parcel described on the attached Ordinance #614 consisting of
16 1.24 acres; and

18 **WHEREAS**, a map of the annexed parcels, along with a copy of the annexation
19 ordinances have been filed with the St. Croix County Clerk and are attached; and
20

21 **WHEREAS**, the parcels annexed by the City of New Richmond were both part of
22 County Supervisor District 14, consisting of Wards 1 and 2, in the Town of Richmond; and
23

24 **WHEREAS**, it is appropriate to move the annexed parcels into County Supervisor
25 District 13, Ward 12, and County Supervisor District 12, Ward 4, in the City of New Richmond;
26 and

28 **WHEREAS**, the parcels annexed by the City of New Richmond and made part of Ward
29 12 and Ward 4 do not cross an assembly district or congressional district line; and

31 **WHEREAS**, the population of the annexed parcels is one; and
32

33 **WHEREAS**, this resolution does not change the number of supervisory districts.
34

35 **NOW, THEREFORE, BE IT RESOLVED** by the St. Croix County Board of
36 Supervisors that the supervisory district boundaries are hereby altered by moving the annexed
37 parcels of land from County Supervisor District 14 to County Supervisor District 12 consisting
38 of Ward 4 and County Supervisor district 14 to County Supervisor District 13 consisting of Ward
39 12 in the City of New Richmond as shown on the attached.


