

## 2024 DESCRIPTION OF CORPORATE LIMITS VILLAGE OF DOUSMAN

All that part of Sections 2, 3, 4, 9, 10, 15 and 16, Town 6 North, Range 17 East, and Sections 26, 33, 34 and 35, Town 7 North, Range 17 East, Village of Dousman, Waukesha County, Wisconsin, bounded and described as follows:
