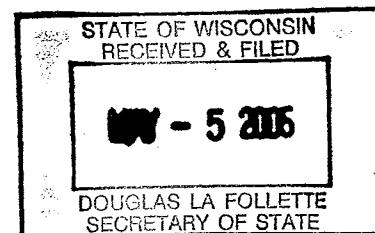

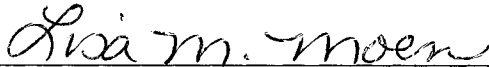

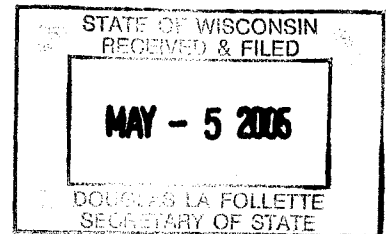

AN ORDINANCE ANNEXING PROPERTY

The Village Board of the Village of Cambridge, Dane County, Wisconsin DO ORDAIN as follows:

WHEREAS, a petition has been filed by Robert L. Scott and Pauline M. Scott for direct annexation of real property owned by them in the Town of Christiana, Dane County, Wisconsin, to the Village of Cambridge; and

WHEREAS, the petition appears to qualify as a unanimous approval petition pursuant to sec. 66.021(12), Wis. Stats.; and

WHEREAS, the State of Wisconsin, Department of Development has been notified of such proposed annexation and has not objected thereto; and

WHEREAS, it appears that it is in the public interest to annex such real estate to the Village of Cambridge, Dane County, Wisconsin;

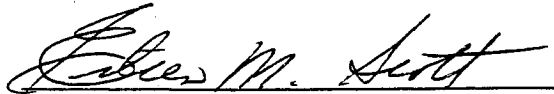
NOW THEREFORE, IT IS HEREBY ORDAINED that the real estate described as follows:

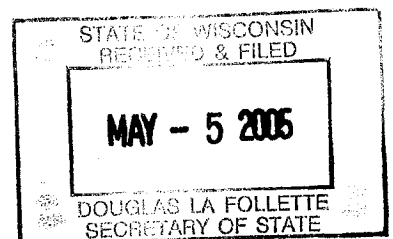
