



ORDINANCE # 781

AN ORDINANCE ANNEXING TERRITORY TO THE CITY OF MEDFORD

THE COMMON COUNCIL OF THE CITY OF MEDFORD, TAYLOR COUNTY, WISCONSIN, DO HEREBY ORDAIN AS FOLLOWS:

SECTION 1: <u>Territory Annexed.</u> In accordance with Wisconsin State Statute 66.021 and the petition for direct annexation filed with the City Clerk on 10 December 1998, signed by all the electors and all of the owners of real property in the territory to be annexed, the following described territory in the Town of Medford, Taylor County, Wisconsin, is annexed to the City of Medford, Wisconsin:

A Parcel of land located in the Northeast Quarter of the Southeast Quarter (NE ¼ SE ¼) Section 34, Township 31 North, Range 1 East, described as "Beginning at a point located on the East Line of Section 34, 347' south of the Northeast Corner of the NE ¼ SE ¼; thence west along a line parallel with the North Line of the NE ¼ SE ¼, 370' to a point; thence south along a line parallel with the East Line of the NE ¼ SE ¼, 132' to a point; thence west along a line parallel with the North Line of the NE ¼ SE ¼, 134.50' to a point; thence south along a line parallel with the East Line of the NE ¼ SE ¼, 172' to a point; thence east along a line parallel with the North Line of the NE ¼ SE ¼, 504.50' to a point located on the East Line of Section 34; thence north along the East Line of the NE ¼ SE ¼, 304' to the place of beginning, Town of Medford, Taylor County, Wisconsin."

- SECTION 2: <u>Effect of Annexation.</u> From and after the date of this ordinance, the territory described in Section 1 shall be part of the City of Medford for any and all purposes provided by law and persons coming or residing within such territory shall be subject to all ordinances, rules and regulations governing the City of Medford.
- SECTION 3: Zoning Classification. Upon recommendation of the Medford Planning Commission, the territory annexed to the City of Medford by this ordinance is permanently designated to be a part of the R 1 "Single-Family Residential" Zoning District, for zoning purposes and subject to all provisions of the City of Medford Zoning Code.
- SECTION 4: <u>Ward Designation</u>. The territory described in Section 1 of this ordinance is hereby made a part of the Second District of the City of Medford, subject to the ordinances, rules and regulations of the City governing wards.
- SECTION 5: <u>Severability</u>. If any provision of this ordinance is invalid or unconstitutional, or if the application of this ordinance to any person or circumstance is invalid or unconstitutional, such invalidity or unconstitutionality shall not affect the other provisions or applications of this ordinance which can be given effect without the invalid or unconstitutional provision or application.
- SECTION 6: <u>Effective Date.</u> This ordinance shall take effect upon passage and publication as provided by law.


