

ORDINANCE NO. 1-99-328

AN ORDINANCE TO ANNEX A PARCEL OF LAND FROM THE TOWN OF DELTON TO THE VILLAGE OF LAKE DELTON, SAUK COUNTY, WISCONSIN

The Village Board of the Village of Lake Delton, Sauk County, Wisconsin does ordain as follows:

SECTION I. Territory Annexed. In accordance with sec. 66.021 of the Wisconsin Statutes and the petition for direct annexation by unanimous approval, signed by all electors residing in the territory and the owners of all of the real property in the territory, of the following described territory, to-wit:

Lot 1 of Certified Survey Map 3904, as recorded in the office of the Register of Deeds for Sauk County, Wisconsin, in Volume 20 of Certified Surveys, page 3904, located in NW1/4 SE1/4, Section 27, T13N, R6E, Town of Delton, Sauk County, Wisconsin.


it is hereby ordered that the above described property be, and the same is hereby annexed to the Village of Lake Delton, Wisconsin, from the Town of Delton, Sauk County, Wisconsin, and it is further ordained that the Village Boundaries are amended to include the above described property within the corporate limits of the Village of Lake Delton.

SECTION II. Effect of Annexation. From and after the date of this ordinance the territory described in section I shall be a part of the Village of Lake Delton for any and all purposes provided by law and all persons coming or residing within such territory shall be subject to all ordinances, rules and regulations governing the Village of Lake Delton.

SECTION III. Temporary Zoning Classification. That the territory annexed is hereby zoned Commercial (C-1) and all provisions of the Village Zoning Ordinance governing the zoning shall be on an interim basis, and only for such period of time as is necessary to amend the Zoning Ordinances of the Village of Lake Delton as prescribed in Section 62.23 (7)(d), Wisconsin Statutes.

SECTION IV. Severability. If any provision of this ordinance is invalid or unconstitutional, or if the application of this ordinance to any person or circumstances is invalid or unconstitutional, such invalidity or unconstitutionality shall not affect the other provisions or applications of this ordinance which can be given effect without the invalid or unconstitutional provision or application.

SECTION V. Effective Date. This ordinance shall take effect upon passage and publication as provided by law.


