**ORDINANCE ANNEXING CERTAIN LANDS
FROM THE TOWN OF GENESEE
TO THE VILLAGE OF WALES,
WAUKESHA COUNTY, WISCONSIN**



THE VILLAGE BOARD OF THE VILLAGE OF WALES, WAUKESHA COUNTY, WISCONSIN, DOES ORDAIN AS FOLLOWS:

SECTION 1: In accordance with § 66.021, Stats., and the Petition for Annexation filed with the Village Clerk on December 16, 1998, the following-described territory in the Town of Genesee, Waukesha County, Wisconsin, is annexed to the Village of Wales, to-wit:

See Exhibit "A", which is appended hereto and incorporated herein by reference.

SECTION 2: The annexed territory is hereby annexed for all municipal purposes.

SECTION 3: The village limits of the Village of Wales, Wisconsin are hereby changed and enlarged so as to include the real estate described in Section 1 of this ordinance, and the official map is amended to include said real estate.

SECTION 4: Should any section, paragraph, sentence, clause, or phrase of this ordinance be declared unconstitutional or invalid for any reason, the remainder shall not be affected thereby.

SECTION 5: All ordinances or parts of ordinances conflicting with or contravening the provisions of this ordinance are hereby repealed.

SECTION 6: This ordinance shall take effect upon passage and posting as provided by law.

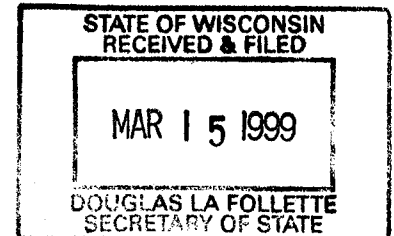

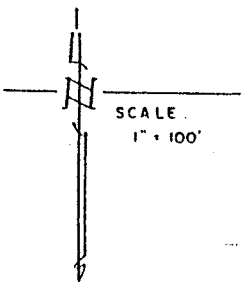
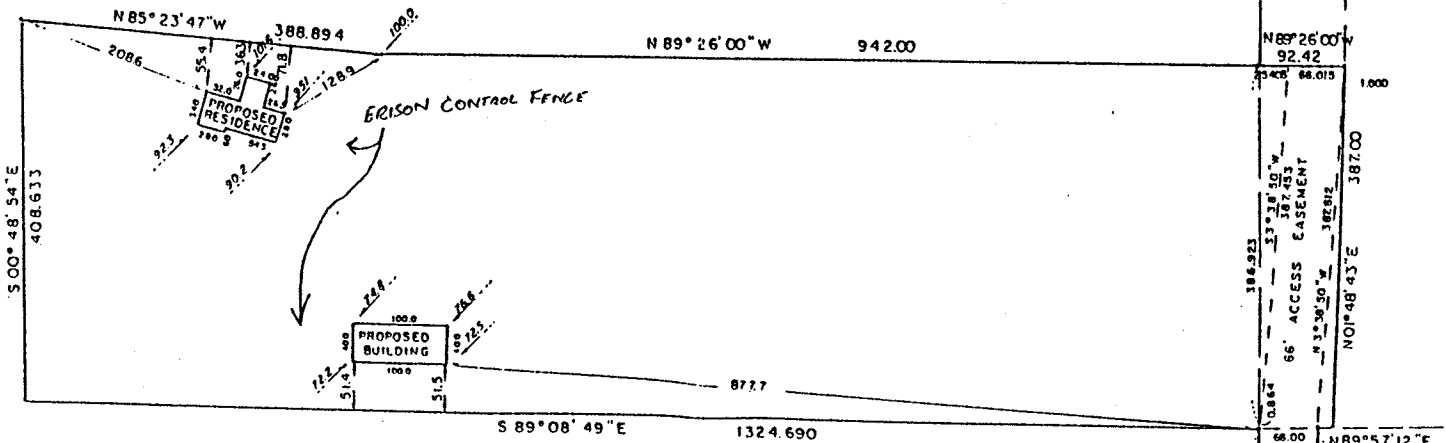
