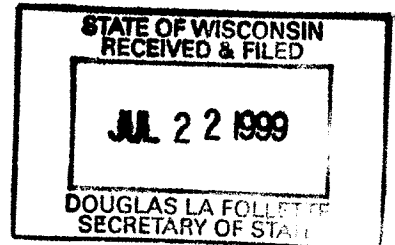

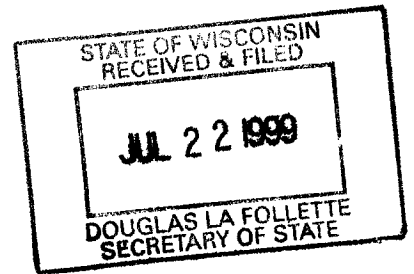

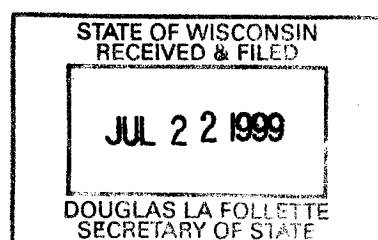

AN ORDINANCE ANNEXING TERRITORY TO THE VILLAGE OF WITTENBERG
FROM THE TOWN OF WITTENBERG, SHAWANO COUNTY, WISCONSIN

Section One: Territory Annexed. Pursuant to the authority granted by Section 66.025, Wis. Stats. the petition for annexation filed by the Village of Wittenberg on land purchased in the Town of Wittenberg contiguous to the Village of Wittenberg.

Description of Land

That part of the Southwest $\frac{1}{4}$ of the northeast $\frac{1}{4}$ of Section 15, township 27 North, Range 11 East Town of Wittenberg, Shawano County, State of Wisconsin, more particularly described as follows: Commencing at the Center of said section 15; thence South 89°39'38" East along the South line of the Southwest $\frac{1}{4}$ of the Northeast $\frac{1}{4}$ of said Section 15, 1,299.13 feet to the East line of the Southwest $\frac{1}{4}$ of the Northeast $\frac{1}{4}$ of said Section 15; thence North 00°42'21" West along said East line 99.03 feet to the point of beginning; thence North 90°39'38" West 178.76 feet, thence North 47°16'26" East 240.58 feet to the East line of the Southwest $\frac{1}{4}$ of the Northeast $\frac{1}{4}$ of said Section 15; thence South 00°42'21" East along said East line 164.31 feet to the point of beginning.

Said parcel containing 0.337 acres more or less.

Section Four: Effect of Annexation: From and after the date of this ordinance, the territory described in Section One shall be a part of the Village of Wittenberg for any and all purposes provided by law and subject to all ordinance, rules and regulations governing the Village of Wittenberg, except until further order of the Village Board.

Section Four: Effective Date: This ordinance shall take effect upon passage and publication.
