



I, Jean Moxon, City Clerk of the City of Neenah, County of Winnebago, State of Wisconsin, DO HEREBY CERTIFY that the following described property was detached from the Town of County of Winnebago and was annexed to the City of Neenah pursuant to Section 66.021(12) of the Wisconsin Statutes by an ordinance (Ordinance No. 1136) adopted by the Common Council of the City of Neenah at a regular meeting held on July 21, 1999.

SECTION 1. Pursuant to Section 66.021, Wis. Stats., the following described territory contiguous to the City of Neenah, and presently in the Town of Neenah, be and the same hereby is, annexed to the City of Neenah, and the corporate limits of said City are hereby extended so as to include said territory, described as follows, to-wit:



A GENERAL ORDINANCE OF THE CITY OF NEENAH ANNEXING CERTAIN LANDS TO THE CITY OF NEENAH, WISCONSIN.


The Common Council of the City of Neenah do ordain as follows:

SECTION 1. Pursuant to Section 66.021, Wis. Stats., the following described territory contiguous to the City of Neenah, and presently in the Town of Neenah, be and the same hereby is, annexed to the City of Neenah, and the corporate limits of said City are hereby extended so as to include said territory, described as follows, to-wit:

Commencing at a found Aluminum Monument at the center of said Section 29; thence along the north-south center section line and the centerline of said Tullar Road S 01°-17′-38″ E, 1389.89 feet to the intersection of said centerline and the centerline of County Road "JJ"; thence along the centerline of said County Road "JJ", N 68°-09′-00″ E, 1407.10 feet to the point of beginning; continue thence along said centerline N 68°-09′-00″ E, 77.17 feet to a point; thence leaving said centerline S 01°-07′-38″ E, 58.91 feet to a point in the south right-of-way line of said County Road "JJ"; thence along said south right-of-way line, S 66°-30′-56″ E, 84.85 feet to a point in the west right-of-way line of U.S. Highway No. 41; thence along said west right-of-way line, S 30°-34′-03″ E, 133.88 feeta point; thence leaving said west right-of-way line, S 01°-07′-38″ E, 71.96 feet to a point; thence S 68°-09′-00″ W, 230.00 feet to a point in the east right-of-way line of Meadow Lane; thence along said east right-of-way line and the northerly projection thereof N 01°-07′-38″ W, 336.88 feet to the point of beginning, containing 1.21 acres. Subject to any and all easements, restrictions, conditions, etc. of record.

SECTION 2. That said territory shall be temporarily zoned I-1, Planned Business District.

SECTION 3. That the limits of the Third Aldermanic District in the City of Neenah are hereby extended in such manner as to include said territory.

SECTION 4. That this ordinance shall be in full force and effect from and after its passage and date of publication.
