ORDINANCE NO. - 1015 - 99

AN ORDINANCE TO ANNEX LANDS LOCATED IN THE NORTHHALF OF SECTION 32, TOWNSHIP 17 NORTH, RANGE 7 WEST, FROM THE TOWN OF ONALASKA TO THE CITY OF ONALASKA.

THE COMMON COUNCIL OF THE CITY OF ONALASKA DOES HEREBY ORDAIN AS FOLLOWS:

SECTION I. Proper petition for direct annexation by unanimous approval, signed by all the owners of all real property in such territory and all of the electors residing in such territory, having been presented to the Common Council of the City of Onalaska, praying for the annexation of the following described territory to the City of Onalaska, Wisconsin from the Town of Onalaska, La Crosse County, Wisconsin.

Parcel I

10-1120-000 (38.52 Acres) NE-NW except part commencing SW corner N89 D11M east 42 feet to east right of way line USH 53 and point of beginning; N89 D11ME 257.01 feet; N49M west 240.8 feet; S79D21M west 178.2 feet; S70D44M west 158.1 feet; S23D58M east along east right of way line 178.4 feet to point of beginning.

Parcel II

10-1122-000 (1.55 Acres) Part NW-NW lying east of USH 53 as described in Volume 338, Page 228, Volume 355, Page 599, except parcels in V 218, Page 516, V228, Page 535, Volume 232, Page 58, Volume 234, Page 96 and in Volume 248, Page 471.

IT IS HEREBY ORDAINED that the above-described property and the same is hereby annexed to the City of Onalaska, Wisconsin, and it is further ordained that the corporate limits of the City of Onalaska are hereby amended to include the above-described property within the corporate limits of the City of Onalaska, Wisconsin.

SECTION II. Sec. 2-1-3(b) of the Code of Ordinances of the City of Onalaska entitled "Ward and Aldermanic District Boundaries" and especially subsection (1) entitled "First Aldermanic District-Ward" is hereby amended to include the above-described property within the boundaries of the First Aldermanic District.

SECTION III. The property is hereby zoned R-1 Residential and all of the provisions of the Code or Ordinances of the City of Onalaska governing said zoning classification shall apply hereto. Such zoning shall be on an interim basis and for such period of time as necessary to amend the zoning ordinance as the City of Onalaska has set forth in Section 62.23(7)d, Wis. Stats.

SECTION IV. This Ordinance shall take effect and be in force from and after its passage and publication.
