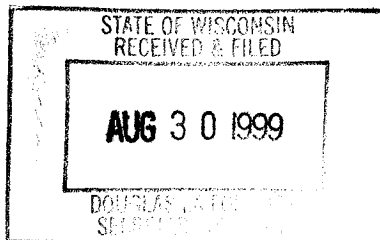

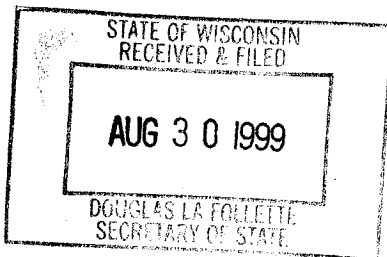

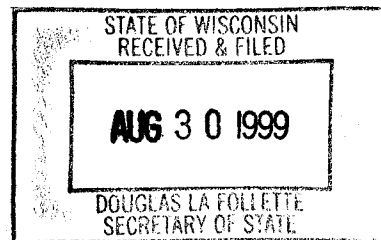

ORDINANCE NO. 1013 B



An Ordinance Annexing Territory to the City of Antigo, Wisconsin.

The Common Council of the City of Antigo do ordain as follows:

Section 1. **TERRITORY ANNEXED:** In accordance with Sec. 66.021(12) of the Wisconsin Statutes and the petition for direct annexation filed with the City Clerk on May 24, 1999 and with the Clerk of the Town of Antigo on May 24, 1999 signed by the owner or owners of all of the land area within the territory to be annexed, the following described territory in the Town of Antigo, Langlade County, Wisconsin, is annexed to the City of Antigo, Wisconsin:

Assessor's Plat of Southwest Quarter, Section 28, Township 31 North, Range 11 East, being Lot 28-26, also described as the East 5 acres of the West 10 acres of the North half of the Northwest Quarter of the Southwest Quarter, except the East 110 feet thereof.

Section 2. **EFFECT OF ANNEXATION:** From and after the effective date of this ordinance, the territory described in Section 1 shall be a part of the City of Antigo for any and all purposes provided by law, and all persons coming or residing within such territory shall be subject to all ordinances, rules and regulations governing the City of Antigo.

Section 3. **WARD AND PRECINCT DESIGNATION:** The territory described in Section 1 of this ordinance is hereby made a part of the Sixth Ward of the City of Antigo, subject to the ordinances, rules and regulations of the City governing wards and precincts.

Section 4. **ZONING:** The City Plan Commission is directed to prepare an amendment to the Zoning Ordinance setting forth permanent classifications and regulations for the zoning of the annexed area and to subject its recommendations to the Council not later than September 7, 1999.


Section 5. **SEVERABILITY:** If any provision of this ordinance is invalid or unconstitutional, or if the application of this ordinance to any person or circumstances is invalid or unconstitutional, such

invalidity or unconstitutionality shall not affect the other provisions or applications of this ordinance which can be given effect without the invalid or unconstitutional provision or application.


Section 6. **EFFECTIVE DATE:** This ordinance shall take effect upon passage and publication as provided by law.

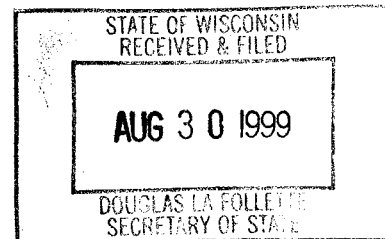

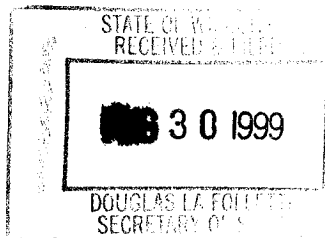

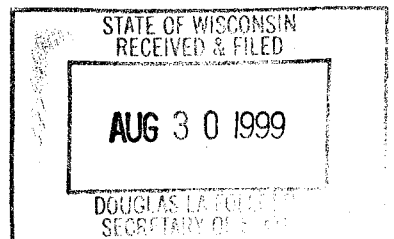

I further certify that there is no person residing in the said territory.

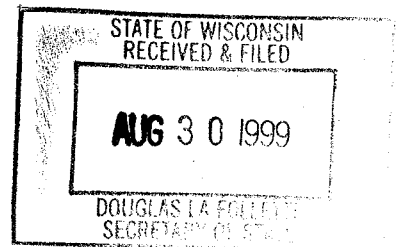
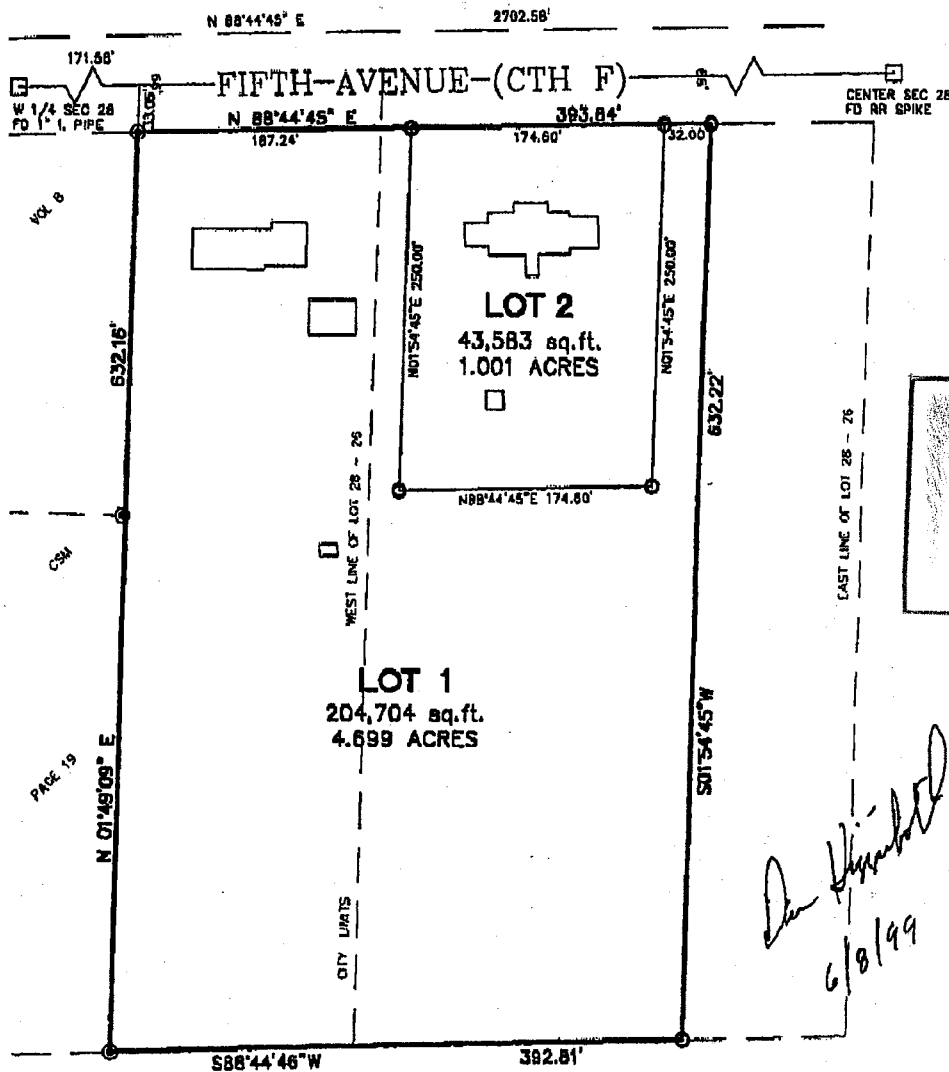
