AN ORDINANCE TO ANNEX A PARCEL OF LAND FROM THE TOWN OF DELTON TO THE VILLAGE OF LAKE DELTON, SAUK COUNTY, WISCONSIN

THE VILLAGE BOARD OF THE VILLAGE OF LAKE DELTON, SAUK COUNTY, WISCONSIN, DO ORDAIN AS FOLLOWS:

SECTION I.

In Accordance with section 66.021 (12) of the Wisconsin Statutes and the Petition for Direct Annexation having been presented to the Village Board of the Village of Lake Delton, signed by the owners of all of the territory and all of the electors residing in the territory praying for the annexation of the follow territory, to-wit:

Lots 1, 2, and 3 of Certified Survey Map No. 1293 as recorded on Vol. 5 of Certified Surveys, page 1293 as #445039, Town of Delton, Sauk County, Wisconsin, together with the 66' right-of-way of Hud Lane and the North 1/2 Xanadu Road adjacent to Lots 2 & 3

to the Village of Lake Delton, Sauk County, Wisconsin, it is hereby ordered that the above described property be, and the same is hereby annexed to the Village of Lake Delton, Wisconsin from the Town of Delton, Sauk County, Wisconsin, and it is further ordained that the Village Boundaries are amended to include the above described property within the corporate limits of the Village of Lake Delton.
