

# CITY OF TOMAHAWK SPECIAL ORDINANCE 2000-3 (ANNEXATION)

# A SPECIAL ORDINANCE ANNEXING TERRITORY TO THE CITY OF TOMAHAWK, LINCOLN COUNTY, WI



The Common Council of the City of Tomahawk ordains as follows:

Territory Annexed: In accordance with Section 66.021 of the Wisconsin Statutes, and SECTION 1 the petition for a direct annexation filed with the City Clerk by all of the owners of the land in the area to be annexed, and there being no resident electors in the territory to be annexed, the following described territory in the Town of Bradley, Lincoln County, Wisconsin, is annexed to the City of Tomahawk:

The Northeast Quarter of the Northeast Quarter (NE 1/4 NE 1/4), Section Ten (10) and the Northwest Quarter of the Northwest Quarter (NW 1/4 NW 1/4) Section 11, Township Thirty-four (34) North, Range Six (6) East, Lincoln County, Wisconsin

The current population of such territory is zero (0).

Effect of Annexation: From and after the adoption date of this ordinance, the territory described in Section 1 shall be a part of the City of Tomahawk for any and all purposes provided by law and all persons coming or residing within such territory shall be subject to all ordinances, rules, and regulations governing the City of Tomahawk.

# SECTION 3

Ward Designation: The territory described in Section 1 of this ordinance is hereby designated as part of the Third Ward of the City of Tomahawk, subject to ordinances, rules, and regulations of the city governing wards.

## **SECTION 4**

Zoning: The territory being annexed to the City of Tomahawk shall become part of the Manufacturing District (M-1) zoning district.







# A SPECIAL ORDINANCE ANNEXAING TERRITORY TO THE CITY OF TOMAHAWK, LINCOLN COUNTY, WI



The Common Council of the City of Tomahawk ordains as follows:

### **SECTION 1**

<u>Territory Annexed:</u> In accordance with Section 66.021 of the Wisconsin Statutes, and the petition for a direct annexation filed with the City Clerk by all of the owners of the land in the area to be annexed, and there being no resident electors in the territory to be annexed, the following described territory in the Town of Bradley, Lincoln County, Wisconsin, is annexed to the City of Tomahawk:

The Southwest Quarter of the Northwest Quarter (SW ¼ NW ¼) and the Northwest Quarter of the Northwest Quarter (NW ¼ NW ¼), Section Thirty-six (36), Township Thirty-five (35) North, of Range Six (6) East, Town of Bradley, Lincoln County, Wisconsin

The current population of such territory is zero (0).

## **SECTION 2**

**Effect of Annexation:** From and after the adoption date of this ordinance, the territory described in Section 1 shall be a part of the City of Tomahawk for any and all purposes provided by law and all persons coming or residing within such territory shall be subject to all ordinances, rules, and regulations governing the City of Tomahawk.

### **SECTION 3**

**Ward Designation:** The territory described is Section 1 of this ordinance is hereby designated as part of the Third Ward of the City of Tomahawk, subject to ordinances, rules, and regulations of the City governing wards.

### **SECTION 4**

**Zoning:** The territory being annexed to the City of Tomahawk shall become part of the Gateway District #2 (GL #2) zoning district.

#### **SECTION 5**

<u>Severability:</u> If any provision of this ordinance is invalid or unconstitutional, or if the application of this ordinance to any person or circumstance is invalid or unconstitutional, such invalidity or unconstitutionality shall not affect the other provisions or application of this ordinance which can be given effect without the invalid or unconstitutional provisions or application.

## **SECTION 6**

**Effective Date:** This ordinance shall take effect upon passage, and publication as provided by law.
