
### **ORDINANCE #259**

AN ORDINANCE ANNEXING TERRITORY TO THE CITY OF NEW RICHMOND, WISCONSIN.

THE COMMON COUNCIL OF THE CITY OF NEW RICHMOND DOES ORDAIN AS FOLLOWS:

Section 1. Territory Annexed. The following described territory presently located in the Town of Richmond and is hereby annexed to the City of New Richmond.

Territory described as follows:



CITY OF NEW RICHMOND GOLF COURSE PROPERTY IN SECTION 35, TOWNSHIP 31 NORTH, RANGE 18 WEST --- AND --- SECTIONS 3 AND 4 IN TOWNSHIP 30 NORTH, RANGE 18 WEST.

It is my understanding that the following description will be used for annexation of property to the City of New Richmond, WI. The property is presently in the Town of Star Prairie and town of Richmond. Part of the following property was previously annexed per Ordinance No. 183 and recorded in Volume 1108 page 263 in the Register of Deeds Office in the St. Croix County, WI Court House (this was excepted form the following described property.

#### DESCRIPTION:

A parcel of land located in part of the Southwest Quarter of the Southwest Quarter, part of the Northwest Quarter of the Southwest Quarter, part of the Northeast Quarter of the Southwest Quarter, part of the Northwest Quarter of the Southeast Quarter, part of the Northwest Quarter of the Southeast Quarter, part of the Southwest Quarter of the Southeast Quarter all in Section 35, Township 31 North, Range 18 West, Town of Star Prairie; and part of the Northwest Quarter of the Northwest of Section 3 and part of the Northeast Quarter of Section 4 in Township 30 North, Range 18 West in the Town of Richmond all in St. Croix County, Wisconsin described as follows:

Railroad; thence, along last said right-of-way, on the arc of a curve, concave to the southeast, a distance of 2,363.49 feet, said curve has a radius of 10,305.52 feet and a chord that bears North 80 degrees 20 minutes 32 seconds East a distance of 2,358.32 feet to the north/south Quarter line of said Section 35; thence, along last said Quarter line and Railroad right-of-way, North 00 degrees 54 minutes 38 seconds West a distance of 50.04 feet; thence, continuing along said rightof-way, along the arc of curve, concave to the south, a distance of 1,122.70 feet, said curve has a radius of 10,355.52 feet and a chord that bears South 89 degrees 58 minutes 17 seconds East a distance of 1,122.15 feet:

Southeast Quarter of said Section 35, South 00 degrees 54 minutes 38 seconds East a distance of 1921.71 feet to the south line of the Southeast Quarter of said Section 35; thence, along last said south line, South 89 degrees 53 minutes 13 seconds West a distance of 234.74 feet; thence South 00 degrees 19 minutes 47 seconds East a distance of 71.53 feet; thence North 89 degrees 11 minutes 13 seconds East a distance of 200.00 feet; thence South 00 degrees 19 minutes 47 seconds East a distance of 155.00 feet; thence South 51 degrees 52 minutes 13 West a distance of 694.00 feet; thence South 40 degrees 10 minutes 13 seconds West a distance of 311.00 feet; thence South 31 degrees 30 minutes 13 seconds West a distance of 247.00 feet; thence North 89 degrees 17 minutes 59 seconds West a distance of 283.06; thence North 21 degrees 26 minutes 13 seconds East a distance of 496.00 feet; thence North 39 degrees 26 minutes 13 seconds East a distance of 456.00 feet; thence North 28 degrees 02 minutes 13 seconds East a distance of 320.00 feet to the north line of said Section 3; thence, along last said north line, South 89 degrees 53 minutes 13 seconds West a distance of 369.86 feet; thence North 21 degrees 58 minutes 21 seconds West a distance of 364.61 feet; thence South 55 degrees 00 minutes 17 seconds West a distance of 214.20 feet; thence South 27 degrees 05 minutes 19 seconds West a distance of 41.48 feet; thence South 88 degrees 25 minutes 35 seconds West a distance of 34.91 feet; thence South 27 degrees 42 minutes 04 seconds West a distance of 203.48 feet to the north line of said Section 4; thence, along last said north line, South 89 degrees 30 minutes 15 seconds West a distance of 206.28 feet to the east line of the West Half of the Fractional Northeast Quarter of the Northeast Quarter of said Section 4; thence, along last said east line, South 00 degrees 34 minutes 37 seconds East a distance of 1372.40 feet to the south line of the Fractional Northeast Quarter of the Northeast Quarter of said Section 4; thence, along last said last said south line, South 89 degrees 46 minutes 55 seconds West a distance of 661.06 feet to the west line of the Fractional Northeast Quarter of the Northeast Quarter of Section 4; thence, along last said west line, North 00 degrees 39 minutes 44 seconds West a distance of 1369.20 feet to the north line of said Section 4, this also being the south line of said Section 35; thence, along last said south line of Section 35, South 89 degrees 30 minutes 15 seconds West a distance of 174.61 feet to the point of beginning. EXCEPTING therefrom Lot 19 of a Certified Survey Map recorded in Volume 14 page 3964 in the Register of Deeds Office in said County. Containing 146.95 acres, this includes land previously annexed. Excepting from the above described land that land that was previously annexed per City of New Richmond Ordinance Number 183 as described in Volume 1108 page 263 in the Register of Deeds Office in said County.

Section 2. Effect of Annexation. From and after the date of this ordinance the territory described in Section 1 shall be a part of the City of New Richmond, for any and all purposes provided by law and all persons coming or residing within such territory shall be subject to all ordinances, rules and regulations governing the City of New Richmond.

Section 3. Permanent Zoning Classification. (a) Upon recommendation to the City Council of the City of New Richmond the territory described above, annexed to the City of New Richmond by this ordinance is designated as (W) Conservation – Parks, Etc. (b) The boundaries of the annexed territory are established as shown on the map filed in the office of the City Clerk of the City of New Richmond.

Section 4. Ward Designation. The territory described in Section 1 of this ordinance is hereby designated as part of Ward 4, Aldermanic District 2 of the City of New Richmond.

Section 5. Severability. If any provision of this ordinance is invalid or unconstitutional, or if the application of this ordinance to any person or circumstances is invalid or unconstitutional, such invalidity or unconstitutionality shall not affect the other provisions or applications of this ordinance which can be given effect without the invalid or unconstitutional provision or application.

Section 6. Effective Date. This ordinance shall take effect upon passage and publication as provided by law.


