

ORDINANCE ANNEXING TERRITORY TO THE VILLAGE OF NORTH FOND DU LAC (MLG PARCEL) Village of M. 710. L 16 Danfield St 16-71.7. L. L. Wi 54537

The Village Board of the Village of North Fond du Lac do ordain as follows:

SECTION 1 - Territory Annexed. In accordance with sec. 66.021 of the Wisconsin Statutes and the petition for direct annexation filed with the Village Clerk on the 13th day of October 1999, signed by a number of electors residing in the territory equal to at least the majority of votes cast for governor in the territory at the gubernatorial election and the owners of at least ½ of the land in area in the territory the following described territory in the Town of Friendship, Fond du Lac County, is annexed to the Village of North Fond du Lac, Wisconsin:

A part of the Southwest ¼ of the Southeast ¼ Section 32, T.16N.-R.17E., Town of Friendship, Fond du Lac County, Wisconsin and being more particularly described in the legal description attached as exhibit A:

The current population of such territory is 0.

SECTION 2. - Effect of Annexation.

From and after the date of this ordinance the territory described in section 1 shall be part of the Village of North Fond du Lac for any and all purposes provided by law and all persons coming or residing within such territory shall be subject to all ordinances, rules and regulations governing the Village of North Fond du Lac.

SECTION 3. - Zoning Classification.

Upon recommendation of the Plan Commission, the territory annexed to the Village of North Fond du Lac by this ordinance is zoned as R-6 multiple family, pursuant to sec. 66.021(7)(a) of Wisconsin Statutes.

SECTION 4. - Severability.






