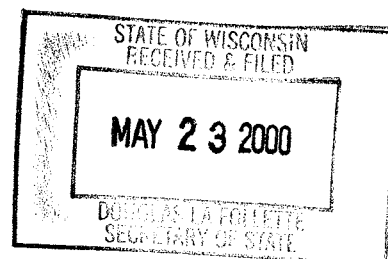

ORDINANCE NO. 2970

AN ORDINANCE ANNEXING PROPERTY
TO THE CITY OF FOND DU LAC

The City Council of the City of
Fond du Lac, Wisconsin, do ordain as follows:

Section 1. Property Annexed. In accordance with Wisconsin Statutes Section 66.021, and a Petition for Direct Annexation filed with the City Clerk's office, signed by all of the owners of the land in the area and assessed value in the territory proposed to be annexed, and there being no electors residing in said territory, the following described territory, which is contiguous to the City of Fond du Lac, Fond du Lac County, Wisconsin, is hereby annexed to the City of Fond du Lac:



Section 2. Effect of Annexation. From and after the date of adoption of this ordinance, the property described in Section 1, herein shall be part of the City of Fond du Lac for any and all purposes provided by law, and all persons coming or residing within such property shall be subject to all ordinances, rules and regulations governing the City of Fond du Lac.

Section 3. Ward Designation. The property described in Section 1 is hereby made a part of the 14th Ward of the City of Fond du Lac and is subject to the ordinances and regulations of the City of Fond du Lac.


Section 4. Effective Date. This ordinance shall take effect and be in force upon its passage as provided by law.

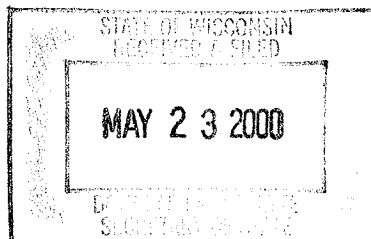

EXHIBIT "B"
DESCRIPTION FOR ANNEXATION

A parcel of land located in the S.W. $\frac{1}{4}$ of the N.E. $\frac{1}{4}$ of Section 26, T.15N.-R.17E. in the Town of Fond du Lac, Fond du Lac County, Wisconsin and being more particularly described as follows:

Commencing at the N.E. Corner of the N.E. $\frac{1}{4}$ of said Section 26, thence Southerly along the West Line of the N.E. $\frac{1}{4}$ of said Section 26, 1,989.68 feet to the point of beginning; thence Easterly 311.77 feet along the existing city limits line; thence Southerly 547.56 feet more or less along the existing city limits line to the Southerly R/W of Reinhardt Road; thence Northwesterly 443.76 feet more or less along the said Southerly R/W line of Reinhardt Road and its northwesterly extension to the centerline of Martin Road and said West Line of the N.E. $\frac{1}{4}$; thence Northerly 231.92 feet more or less along said centerline of Martin Road and said West line to the point of beginning containing 2.79 acres (121,575 sq. ft.) of land more or less.

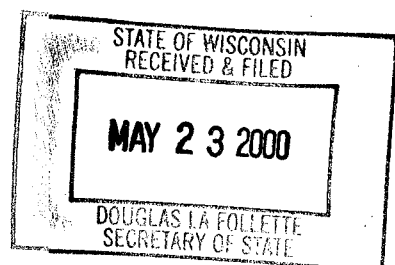


EXHIBIT "A"
