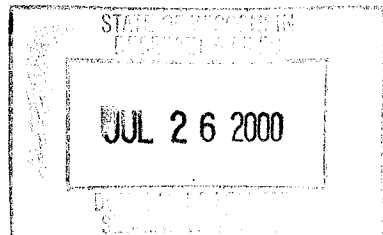



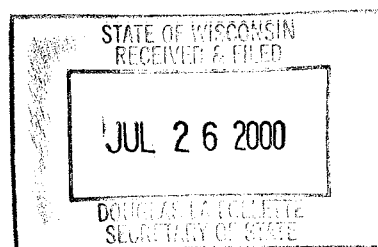

ORDINANCE NO. 13-3-3

AN ORDINANCE DEANNEXING TERRITORY
FROM THE VILLAGE OF NESHKORO,
MARQUETTE COUNTY, WISCONSIN

The Village Board of the Village of Neshkoro, Marquette County, Wisconsin does ordain as follows:

SECTION 1. In accordance with Section 66.022 of the Wisconsin Statutes, and the Petition for the Deannexation filed with the Village Clerk and the Petition signed by a majority of the electors residing in the territory therein described and by the owners of more than one-half of the land in area in the territory therein described, and which said territory therein described is now within the Village of Neshkoro, Marquette County, Wisconsin, the following described territory of the Village of Neshkoro, Marquette County, Wisconsin, is hereby deannexed and returned to the Town of Neshkoro, Marquette County, Wisconsin, upon proper acceptance.

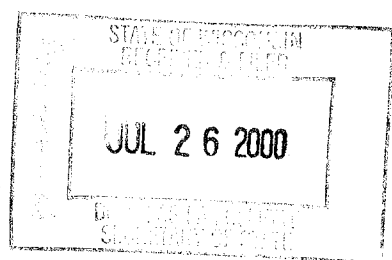
The S1/2 of the NE1/4 of the NE1/4 of Section 17, Township 17 North, Range 11 East, Village of Neshkoro, Marquette County, Wisconsin.

SECTION 2. From and after the effective date of this ordinance and the acceptance by the Town of Neshkoro the territory described in Section 1 hereof shall be a part of the Town of Neshkoro for any and all purposes provided by law and all persons coming or residing within such territory shall be subject to all ordinances, rules and regulations governing the Town of Neshkoro.

SECTION 3. At the present time the zoning on said territory should continue as it presently is.

SECTION 4. If any of the provisions of this ordinance are invalid, unconstitutional, or if the application of this ordinance to any person or circumstance is invalid or unconstitutional, such invalidity or unconstitutionality shall not effect the other provisions or applications of this ordinance which can be given effect without the invalid or unconstitutional provision or application.

SECTION 5. This ordinance shall take effect upon passage and publication as provided by law.



AN ORDINANCE ANNEXING TERRITORY

The Town Board of the Town of Neshkoro, Marquette County, Wisconsin does ordain as follows:

SECTION 1. In accordance with Section 66.022 of the Wisconsin Statutes, and the Petition for the Deannexation filed with the Village of Neshkoro Clerk and the Petition signed by a majority of the electors residing in the territory therein described and by the owners of more than one-half of the land in area in the territory therein described, and which said territory therein described is now within the Village of Neshkoro, Marquette County, Wisconsin, the following described territory of the Village of Neshkoro, Marquette County, Wisconsin, is hereby deannexed and annexed to the Town of Neshkoro, Marquette County, Wisconsin.

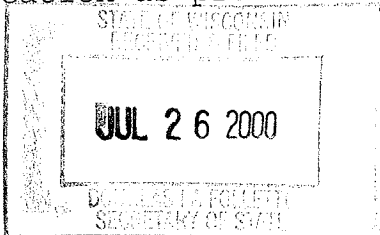
The S1/2 of the NE1/4 of the NE1/4 of Section 17,
Township 17 North, Range 11 East, Village of Neshkoro,
Marquette County, Wisconsin.

SECTION 2. From and after the effective date of this ordinance the territory described in Section 1 hereof shall be a part of the Town of Neshkoro for any and all purposes provided by law and all persons coming or residing within such territory shall be subject to all ordinances, rules and regulations governing the Town of Neshkoro.

SECTION 3. At the present time the zoning on said territory should continue as it presently is, and shall be subject to the same zoning rules and regulations as the rest of the Township of Neshkoro.


