



# PETITION FOR DIRECT ANNEXATION BY UNANIMOUS APPROVAL PURSUANT TO SECTION 66.021(12), WISCONSIN STATUTES WHERE NO ELECTORS RESIDE IN TERRITORY

We, the undersigned, constituting all of the owners of the real property in which no electors reside in the following territory of the town of Oakfield, Fond du Lac County, Wisconsin, lying contiguous to the Village of Oakfield, petition the Village Board of the Village of Oakfield to annex the territory described below and shown on the attached scale map to the Village of Oakfield, Fond du Lac County, Wisconsin.

A part of the Southwest 1/4 of Section 14, T. 14 N.-R. 16 E., Town of Oakfield, Fond du Lac County, Wisconsin and being more particularly described as follows:

Beginning at the Southeasterly right-of-way line of the Wild Goose State Trail (former Chicago & Northwestern Railroad right-of-way) and the West corporate limits line of the Village of Oakfield; thence South along said corporate limits line, 500 feet; thence West, 623 feet more or less; thence Northeasterly along said Southeasterly right-of-way line, 800 feet more or less to the point of beginning and containing 3.57 acres of land more or less.

The current population of such territory is 0.

We, the undersigned, elect that this annexation shall take effect to the full extent consistent with outstanding priorities of other annexation, incorporation or consolidation proceedings, if any.



## AN ORDINANCE ANNEXING TERRITORY TO THE VILLAGE OF OAKFIELD, PURSUANT TO THE PROVISIONS OF CHAPTER 66.021 WIS. STATS.

BE IT ORDAINED by the Village of Oakfield, Fond du Lac County, State of Wisconsin as follows:

- Whereas, a petition for direct annexation has been presented on February 7, 2001 to the Oakfield Village Board signed by all owners and electors of the said territory being proposed for annexation, and
- Whereas, the annexation of such territory is deemed necessary for the welfare of the residents and property owners thereof and the residents and property owners of the village as a whole, and
- 3. Whereas, the annexation of such territory is deemed in compliance with the objectives of the village's master plan, and
- Whereas, the comments, if any, of the Wisconsin Department of Administration having been considered by the Village Board.

Now therfore, be it further ordained that

- 1. There is hereby annexed to the Village of Oakfield, Fond du Lac County, State of Wisconsin, and incorporated within the corporate boundaries thereof, the following territory adjoining the present corporate boundaries of the village more particularly described in Exhibit A, being the legal description of said territory.
- The territory so annexed shall be designated as zoning district "I". Industrial Zone.
- 3. The map attached as Exhibit B is an accurate map of the territory annexed, and such map is hereby adopted as the official map of the territory annexed.


