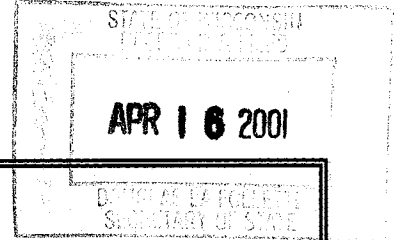

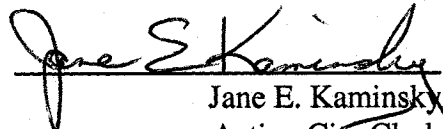

DIRECT ANNEXATION ORDINANCE

APR 16 2001

The City Council of the City of Two Rivers does ordain as follows:

SECTION 1. Pursuant to the provisions of Wisconsin State Statutes Section 66.021, the following territory presently lying within the Town of Two Rivers, is hereby annexed to the City of Two Rivers:

A part of the SW1/4 of the NW1/4, NW1/4 of the NW1/4 and the NE1/4 of the NW1/4 of Section 26, Township 20 North, Range 24 East, in the Town of Two Rivers, Manitowoc County Wisconsin, described as follows:

Commencing at the Center of said section; thence N00°54'15" E along the east line of the NW1/4 of said section and the east line of the Forest Hills Subdivision, 1324.05 feet to the 2" iron pipe marking the NE corner of the SE1/4 of the NW1/4 of said section; thence S89°30'45"W along the north limit of said subdivision and the north limit of the SE1/4 of the NW1/4 of said section, 1343.59 feet to the 2" iron pipe marking the NW corner of the SE1/4 of the NW1/4 of said section and a point of beginning of the following described parcel; thence S1°28'45"W along the west line of said subdivision, 121.45 feet; thence N88°34'45"W, 175.56 feet to the iron fence post; thence N88°36'20"W, 73.60 feet; thence N1°21'23"E, 874.39 feet; thence S88°36'00"E, 250.00 feet to the east line of the NW1/4 of the NW1/4 of said section, thence S1°24'00"W along said line, 467.94 feet; thence Southeasterly along the arc of a curve to the right, 73.07 feet, having a radius of 130.00 feet, a central angle of 32°12'15" and whose long chord bears S14°42'07.5"E, 72.11 feet; thence S1°24'00"W, 155.09 feet to the north line of 49th Street; thence S89°30'45"W along said north line, 20.01 feet to the east line of the NW1/4 of the NW1/4 of said section; thence S1°24'00"W along said east line, 60.03 feet to the place of beginning.

Containing 222,347 square feet (5.104 acres) of land, more or less.

SECTION 2. The territory described in Section 26 shall be part of the City of Two Rivers for any and all purposes provided by law, and all persons coming to or residing within said territory shall be subject to all ordinances, rules, and regulations governing the City of Two Rivers.

SECTION 3. Pursuant to Section 66.021(7) of the Wisconsin State Statutes, said territory shall be classified for zoning purposes as R-1, Single Family Residence District.

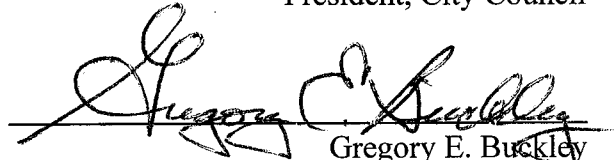
SECTION 4. Upon passage of this ordinance, the City Clerk for the City of Two Rivers is hereby directed to transmit five (5) certified copies of this ordinance, together with five (5) copies of a plat showing the boundaries of the territory attached, to the Secretary of the State of Wisconsin.

SECTION 5. This ordinance shall take effect upon passage and publication hereof.

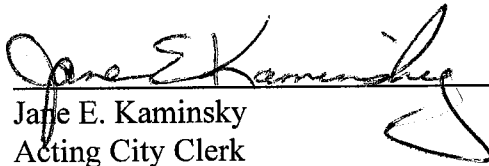
