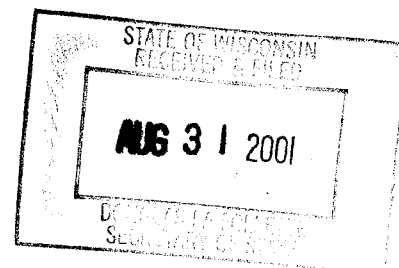

This parcel was annexed from the Town of Hull. The current population of the area to be annexed is 2.

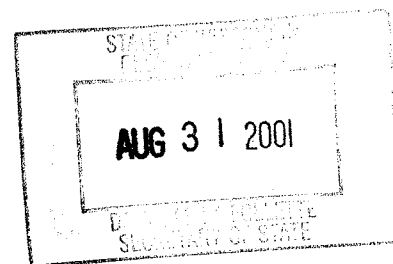

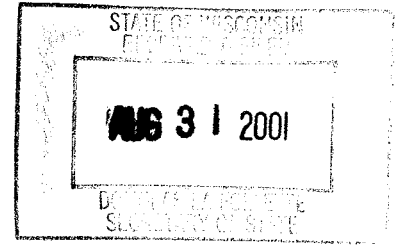

AN ORDINANCE ANNEXING TERRITORY TO THE CITY OF STEVENS POINT, WISCONSIN

The Common Council of the City of Stevens Point, Wisconsin, do ordain as follows:

SECTION I: Territory Annexed. In accordance with Section 66.0217 of the Wisconsin Statutes, the following described territory in the Town of Hull, Portage County, Wisconsin, is annexed to the City of Stevens Point, Wisconsin:

That part of Government Lot 1, Section 30, Township 24 North, Range 8 East, Town of Hull, Portage County, Wisconsin described as follows:

The south 50 feet of the east 528 feet of said Lot 1, except the east 245.72 feet.

Said annexation contains approximately 0.30 acres.


SECTION II: Effect of Annexation. From and after the date of this ordinance, the territory described in Section I shall be a part of the City of Stevens Point for any and all purposes provided by law and all persons coming or residing within such territory shall be subject to all ordinances, rules and regulations governing the City of Stevens Point.


SECTION III: Zoning Classification. Such land shall be temporarily designated as "R-2" Single Family Zoning.

SECTION IV: Legislative District and Ward Designation. The territory described above is hereby made a part of the **71st Assembly District** and **4th Ward** of the City of Stevens Point subject to the ordinances, rules and regulations of the City governing wards.

SECTION V: Severability. If any provision of this ordinance is invalid or unconstitutional or if the application of this ordinance to any person or circumstance is invalid or unconstitutional, such invalidity or unconstitutionality shall not affect any provisions or applications of this ordinance which can be given effect without the invalid or unconstitutional provision or application.

SECTION VI: Effective Date: This ordinance shall take effect upon passage and publication as provided by law.
