AN ORDINANCE ANNEXING THE HEREIN DESCRIBED PROPERTY TO THE CITY OF VERONA, DANE COUNTY, WISCONSIN

The Common Council of the City of Verona, Dane County, State of Wisconsin, by at least a two-thirds (2/3) vote of its members, does hereby ordain as follows:

Section 1. <u>Territory Annexed</u>.

In accordance with Section 66.021 of the Wisconsin Statutes and the Petition for Direct Annexation filed with the City Clerk on September 28, 2001, signed by the owners and electors of all of the land area and all of the real property in assessed value in the territory, there being two (2) electors residing in said territory, the following territory in the Town of Verona, Dane County, Wisconsin as described in Exhibit A as attached hereto.

Section 2. Effect of Annexation.

From and after the date of this Ordinance, the territory described in Exhibit A shall be a part of the City of Verona, Dane County, Wisconsin for any and all purposes provided by law and all persons coming or residing within such territory shall be subject to all ordinances, rules and regulations governing the City of Verona.

Section 3. Temporary Zoning Classification.

Upon recommendation by the Plan Commission, the territory annexed to the City of Verona by this Ordinance is temporarily designated to be a part of the following district of the City for zoning purposes and subject to all provisions of the zoning ordinance of the City of Verona relating to such district classification and to zoning in the City: RA (Rural Agriculture)

Section 4. Voting Districts.

The territory annexed shall be within the following voting districts:

- (a) Aldermanic District No. 1
- (b) Ward No. 1
- (c) Dane County Supervisory District No. 32

Section 5. <u>Severability</u>.

If any provision of this Ordinance is invalid or unconstitutional, or if the application of this Ordinance to any person or circumstances is invalid or unconstitutional, such invalidity or unconstitutionality shall not affect the other provisions or applications of this Ordinance which can be given effect without the invalid or unconstitutional provision or application.
