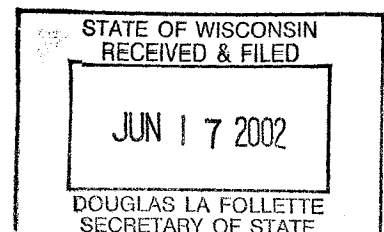

ORDINANCE NO. 2002-2

AN ORDINANCE ANNEXING CERTAIN TERRITORY AND INCORPORATING THE SAME WITHIN THE CORPORATE BOUNDARIES OF THE VILLAGE OF SAUK CITY, PURSUANT TO THE PROVISIONS OF WISCONSIN STATUTES ANNOTATED, SECTION 66.0217(2).

BE IT ORDAINED BY THE VILLAGE BOARD OF THE VILLAGE OF SAUK CITY, SAUK COUNTY, WISCONSIN, AS FOLLOWS:

PREAMBLE

1. A petition for direct annexation by unanimous consent in writing has been presented to the Village Board of the Village of Sauk City, signed by all the electors and owners of real and personal property of the territory herein described requesting annexation of their properties to the Village of Sauk City.

2. The petition has been reviewed by the State of Wisconsin Department of Administration, and said Department has determined the proposed annexation is in the public interest.

3. It appears that the prosperity of this Village and of the territory herein described will be materially retarded and the safety and welfare of the inhabitants and property thereof endangered if such property is not annexed.

4. The annexation of such territory is necessary for the welfare of the residents and property owners hereof and of this Village as a whole.

NOW THEREFORE, be it ordained by the Village Board for the Village of Sauk City, Sauk County, as follows:

1. Annexation of Territory.

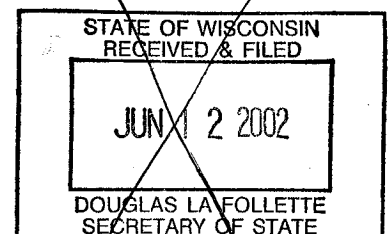
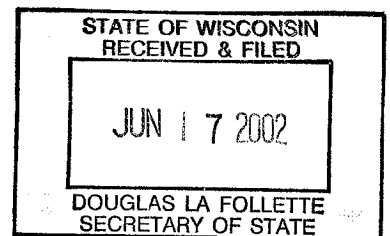
1.1 There is hereby annexed to the Village of Sauk City, County of Sauk, State of Wisconsin, and incorporated within the corporate boundaries thereof, the following territory adjoining the present corporate boundaries of the Village:

2. Zoning.

2.1 The property in Exhibit A is to be zoned residential

3. New corporate limits.



3.1 The corporate limits of the Village of Sauk City are hereby extended and increased so as to include and embrace within the corporate limits of the Village of Sauk City, the territory described in Section 1 hereof, and such territory is hereby declared to be a part of the Village of Sauk City.

4. Accuracy of map of annexed territory.

4.1 The map attached to this Ordinance as Exhibit A is an accurate map of the territory annexed, and such map is adopted as the official map of the territory annexed, and the President of the Village of Sauk City, is hereby authorized and directed to certify that the map is an accurate map of the territory annexed under the provision of this ordinance, and to record in the Office of the Register of Deeds for Sauk County, State of Wisconsin, this ordinance together with a certified copy of the official map attached.

5. Population


5.1 The Village Board has determined that the population of the annexed territory is -2-.

6. Effective Date.

6.1 This ordinance shall take effect as soon as permitted by law.

Passed by the unanimous vote of the Village Board of the Village of Sauk City, on the 14th day of May, 2002.

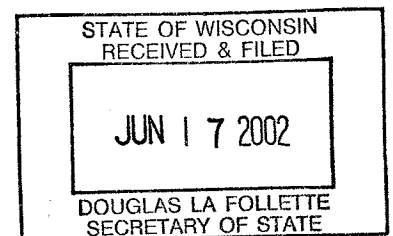

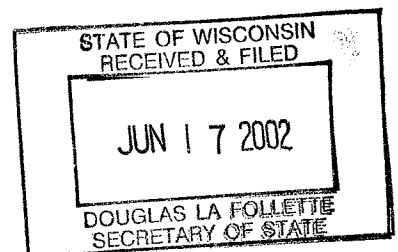

WHERE ELECTORS RESIDE IN TERRITORY**

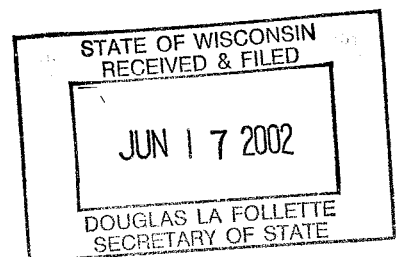
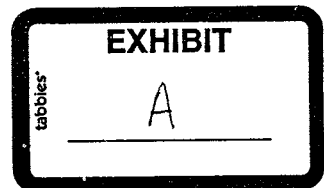
