
I, Blyann Johnson, City Clerk of the City of Osseo, County of Trempealeau, State of Wisconsin, DO HEREBY CERTIFY, that the following described territory was annexed to the City of Osseo, pursuant to Wisconsin Statutes 66.0217, by adoption of Section 13-2-7, Chapter 2, Title 13 of the City of Osseo Code of Ordinances, by the Common Council of the City of Osseo at a regularly held meeting on July 8, 2002. I hereby further certify that the population of said territory is two (2), and that the same is true and complete copy of said ordinance as adopted.

A parcel of land located in the Southwest Quarter of Section 10, Township 24 North, Range 7 West, Town of Sumner, County of Trempealeau, State of Wisconsin, described as follows: Commencing from the West Quarter corner of Section 10, Township 24 North, Range 7 West; thence South 00 12' 00" East, along the westerly line of the Southwest Quarter of said Section 10, a distance of 1,336.14 feet; thence South 89 17' 00" East a distance of 639.21 feet to the True Point of Beginning; thence continuing South 89 17' 00" East a distance of 165.11 feet; thence South 00 17' 19" West a distance of 100.00 feet; thence North 89 17' 00" West a distance of 207.39 feet; thence North 23 16' 17" East a distance of 108.28 feet to the True Point of Beginning. Parcel contains 18,626 square feet or 0.4 acres and delineated on the Annexation Map attached hereto.

# AN ORDINANCE ANNEXING TERRITORY TO THE CITY OF OSSEO, WISCONSIN

The Common Council of the City of Osseo, Wisconsin do ordain as follows:


SECTION 1. Territory Annexed. Direct Annexation in accordance with sec. 66.021 of the Wisconsin Statutes and the petition for direct annexation filed with the City Clerk on the 17<sup>th</sup> day of May, 2002; signed by a number of electors residing in the territory equal to at least the majority of votes cast for governor in the territory at the last gubernatorial election and the owners of at least ½ of the land in area in the territory, the following described territory in the Town of Sumner, Trempealeau County, Wisconsin, is annexed to the city of Osseo, Wisconsin:

A parcel of land located in the Southwest Quarter of the Southwest Quarter of Section 10, Township 24 North, Range 7 West, Town of Sumner, County of Trempealeau, State of Wisconsin, described as Follows:

Commencing from the West Quarter corner of Section 10, Township 24 North, Range 7 West; thence South 00° 12' 00" East, along the westerly line of the Southwest Quarter of said Section 10, a distance of 1,336.14 feet; thence South 89° 17' 00" East a distance of 639.21 feet to the True Point of Beginning; thence continuing South 89° 17'00" East a distance of 165.11 feet; thence South 00°17'19" West a distance of 100.00 feet; thence North 89°17'00" West a distance of 207.39 feet; thence North 23°16'17" East a distance of 108.28 feet to the True Point of Beginning. Parcel contains 18,626 square feet or 0.4 acres.

SECTION 2. Effect of Annexation. From and after the date of this ordinance the territory described in Section 1 shall be a part of the city of Osseo for any and all purposes provided by law and all persons coming or residing within such territory shall be subject to all ordinances, rules and regulations governing the city of Osseo.

SECTION 3. The plan commission is directed to prepare an amendment to the zoning ordinance setting forth permanent classifications and regulations for the zoning of the annexed area and to submit its recommendations to the Council not later than October 14, 2002.



SECTION 4. Ward Designation. The territory described in Section 1 of this ordinance is hereby made a part of the 3<sup>rd</sup> ward of the City of Osseo, subject to the ordinances, rules and regulations of the City of Osseo governing wards.

SECTION 5. Severability. If any provision of this ordinance is invalid or unconstitutional, or if the application of this ordinance to any person or circumstances is invalid or unconstitutional, such invalidity or unconstitutionality shall not affect the other provisions or applications of this ordinance which can be given effect without the invalid or unconstitutional provision or application.

SECTION 6. Effective Date. This ordinance shall take effect upon passage and publication as provided by law.
