#### **CHARTER ORDINANCE 4**

# ESTABLISHING STAGGERED TERMS FOR ALDERPERSONS AND AMENDING MAYORAL TERM TO THREE YEARS

The Common Council of the City of Fitchburg, Dane County, Wisconsin ordains as follows:

<u>Section 1</u> – Section 4-1 is hereby amended to read:

Sec. 4-1. - Form of government.

The city is a state political corporation, has the powers and privileges afforded cities under the constitution and laws of the state and of the United States of America. Its corporate authority is vested in a mayor and common council comprised of the mayor and eight alderpersons, two from each of four aldermanic districts. Commencing with the spring election in April of 2020, the mayor is to be elected for a three year term, and the alderpersons are to be elected for two year terms on a staggered basis with alderpersons for District 1 seat 2, District 2 seat 4, District 3 seat 6, and District 4 seat 8 elected in even years and alderpersons for District 1 seat 1 District 2 seat 3, District 3 seat 5, and District 4 seat 7 elected in odd years.

# ection 2 – Section 4-23 is hereby amended to read:

Sec. 4-23. - Composition.

(a) Two classes of Alders. The common council shall consist of the mayor and eight alderpersons elected for seats numbered as follows: District 1, seats 1 and 2; District 2, seats 3 and 4; District 3, seats 5 and 6; and District 4, seats 7 and 8. Alderpersons shall be divided into two (2) classes, one (1) class of Alderpersons to be elected in odd years and one (1) class to be elected in even years as follows:

Alderpersons for District 1 seat 2, District 2 seat 4, District 3 seat 6, and District 4 seat 8 to be elected in even years.

Alderpersons for District 1 seat 1 District 2 seat 3, District 3 seat 5, and District 4 seat 7 to be elected in odd years.

For purposes of nominations, primaries, ballots, election procedures and filling of vacancies, each numbered seat shall be considered a separate office. The mayor and all alderpersons shall be elected in the spring election held on the first Tuesday in April.

- (b) Transition to Staggered Terms. During the spring election in April of 2019, the alderpersons of the City of Fitchburg shall be elected as follows:
  - 1. Alderpersons for District 1 seat 2, District 2 seat 4, District 3 seat 6, and District 4 seat 8 shall be elected for a one (1) year term.
  - 2. Alderpersons for District 1 seat 1 District 2 seat 3, District 3 seat 5, and District 4 seat 7 shall be elected for a two (2) year term.

Commencing with the spring election in April of 2020, the alderpersons are to be elected for two year terms on a staggered basis as described in subsection (a) above.

### Section 3 - Section 4-62 is hereby amended to read:

Sec. 4-62. - Orientation meeting.

DEvery year, immediately after the adjournment of the first monthly meeting in April (held on the second Tuesday of the month and which shall be held by the outgoing common council members), there shall be held a common council orientation meeting for the new common council members who will assume their positions the third Tuesday in April. The orientation meeting shall include, but not be limited to a discussion of Robert's Rules of Order, open meetings law, open records law, ethics code, and other topics of interest.

# <u>Section 4</u> – Section 4-63 is hereby amended to read:

Sec. 4-63. - Organizational meeting.

- (a) The organizational meeting is to be held on the third Tuesday in April every year. At this meeting the council president will be elected. The council president may present nominations for standing committees for immediate action by the common council. A majority of those present and voting shall be required to confirm nominations.
- (b) The mayor may also present nominations for other committees and commissions for immediate action by the common council as provided in this article. Referrals to committees and commissions may be made at the organizational meeting, as well as approval of bills, and any item deemed necessary for immediate action.

### <u>Section 5</u> – Section 8-37 is hereby amended to read:

Sec. 8-37. - Election.

During the spring election in 2019 only, the Mayor shall be elected for a one year term commencing on the third Tuesday of April 2019 and continuing for a one year term or until a successor is elected and qualified.

Commencing with the 2020, the mayor shall be elected every three years for a term of office commencing on the third Tuesday of April in the year of election and continuing for three years or until a successor is elected and qualified.

<u>Section 6</u> — This ordinance shall take effect 60 days after publication unless, within the 60-day period a petition conforming to the requirements of Wis. Stat. § 8.40 and signed by a number of electors of the City equal to not less than 7 percent of the votes cast in the City for governor at the last general election is filed with the City Clerk demanding that the ordinance be submitted to a vote of the electors. In that event, this ordinance will not take effect until it is submitted to a referendum and approved by a majority of the electors voting in the referendum.

Commencing with the 2020, the mayor shall be elected every three years for a term of office commencing on the third Tuesday of April in the year of election and continuing for three years or until a successor is elected and qualified.

Section 8.— This ordinance shall take effect 80 days after publication unless, within the 80-day period a patition conforming to the requirements of Wis. Stat. § 8.40 and eigned by a number of electors of the City orgula to not tess that 7 percent of the votes cast in the City for governor at the last general election is filled with the City close demanding that the ordinance be submitted to a vote of the electors.
