AN ORDINANCE ANNEXING CERTAIN LANDS OF THE TOWN OF WAUKESHA TO THE CITY OF WAUKESHA, WISCONSIN

THE COMMON COUNCIL OF THE CITY OF WAUKESHA DO ORDAIN AS FOLLOWS:

SECTION I. In accordance with Section 66.021 of the Wisconsin Statutes and petition for annexation filed with the City Clerk on the 6th day of January, 2003, the following described territory in the Town of Waukesha, Waukesha County, Wisconsin is annexed to the City of Waukesha:

All that part of the Southeast ¼ (SE ¼) of the Southwest ¼ (SW ¼) of Section 10, Town 6 North, Range 19 East, Town of Waukesha, Waukesha County, Wisconsin, bounded and described as follows:

Commencing at the South ¼ of said Section 10; thence Northerly along the East line of said Southwest ¼ of Section 10, 283 feet M/L to the point of beginning of the herein described property; thence Northerly along said East ¼ section line, 120 feet; thence Westerly, 339.06 feet to the east line of the Canadian National Railroad right-of-way; thence Southwesterly along said right-of-way, 124.41 feet; thence Easterly, 368.92 feet to the point of beginning. Containing 0.974 Acres M/L.


Excepting therefrom, that part of the right-of-way of West Avenue previously annexed to the City of Waukesha. Containing 0.091 Acres M/L.

Net acreage of proposed annexation is 0.883 Acres M/L.

SECTION II. The above shall be zoned pursuant to the authority granted in Section 66.021(7) of the Wisconsin Statutes as T-1, Temporary Zoning District

SECTION III. The annexed territory is hereby made a part of the Sixth Aldermanic District, and is in the Fiftieth Ward of the City of Waukesha and is annexed for all municipal purposes including annexation for school purposes and is hereby made a part of the School District of Waukesha, and subject to laws governing the same.

SECTION IV. The City limits of the City of Waukesha, Wisconsin are hereby changed and enlarged as so to include the real estate described in Section I of this ordinance and the official map is amended to include said real estate.



SECTION V. Should any section, paragraph, sentence, clause or phrase of this ordinance be declared unconstitutional or invalid for any reason, the remainder shall not be affected thereby.

SECTION VI. All ordinances or parts of ordinances inconsistent with or contravening the provisions of this ordinance are hereby repealed.

SECTION VII. This ordinance shall be in full force and effect from and after its passage and publication by law.




UNSHADED AND NON-CROSSHATCHED HATCHED AREAS ARE CITY OF WAUKESHA.
