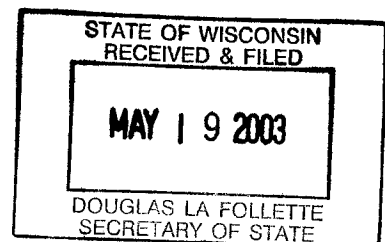

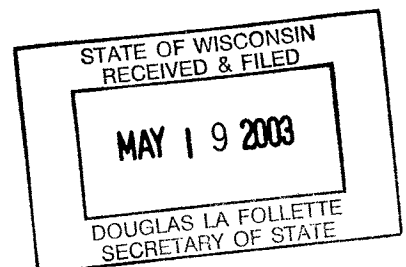

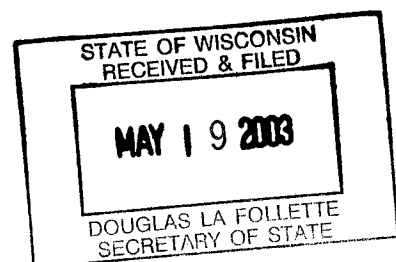

## Public Notice of Possible Ordinance Amendment

To Annex Real Estate to the Village of Fall Creek

Pursuant to §66.0217(2), Wis. Stats. and to Adopt §268-50 E. of the Village Code

BE IT ORDAINED by the Village Board of the Village of Fall Creek as follows:

Chapter 268 of the code of the village of Fall Creek is hereby amended to read as follows:

### §268-50 E. Zoning, Annexation

Section One: That the real estate described in Section Two be and is hereby annexed to the Village of Fall Creek under §66.0217(2), Wis. Stats. That in accord with §268-50 A. of the Village Code, the real estate shall temporarily be zoned UT (Urban Transitional) until permanent zoning is recommended to the Village Board by the Planning Commission.

Section Two: That §268-50 E. of the Village Code be created to read:

E. In accordance with §66.0217(2), Wis. Stats., and the petition for direct annexation upon unanimous consent, filed with the Village Clerk-Treasurer on January 22, 2003, signed by all of the owners of the real estate in question and all of the electors residing upon the said real estate, the following described territory in the Town of Lincoln, Eau Claire County, Wisconsin, is annexed to the Village of Fall Creek, Wisconsin:

The NE 1/4 of the NW 1/4 of the NW 1/4 of the NE 1/4 and the SW 1/4 of the NE 1/4 except the Highway 12 right of way as described in Volume 140 of Records, Page 350, and also except Lot 1 of Certified Survey Map# 1610, recorded in Volume 8 of Certified Survey Maps, Page 328, as Document# 764681.

(1) Effect of Annexation. From and after the date of this subsection E., the territory described above shall be part of the Village of Fall Creek for any and all purposes provided by law, and all persons coming or residing within such territory shall be subject to all ordinances, rules and regulations governing the Village of Fall Creek.

(2) Ward Designation. The territory described in this subsection E., is hereby made a part of Ward 2 of the Village of Fall Creek, subject to the ordinances, rules and regulations of the Village governing wards.

Section Three: That Sections One and Three need not be codified. That this ordinance shall take effect upon its adoption in accord with §66.0217(2) and (8), Wis. Stats.

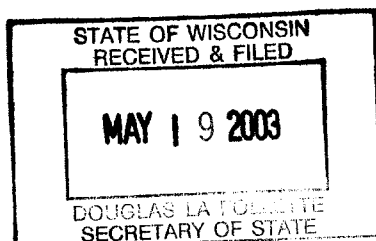
