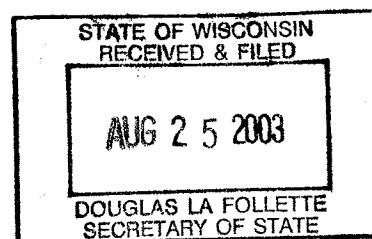

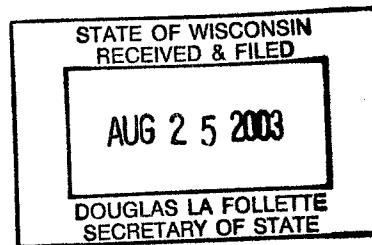

**ORDINANCE NO. 2003-12**

**WHEREAS**, the Petitioners, Bruce Grafenauer, Phyllis Grafenauer, David Thomas, Roxanne Thomas, William Joas and Carolyn Joas, are all of the electors residing in and owners of the following described real estate located within the Town of East Troy, Walworth County, Wisconsin, and;

**WHEREAS**, the Petitioners have filed a petition for direct annexation by unanimous approval of the land owned and occupied by them with the Village Clerk of East Troy, Wisconsin and the Town Clerk of East Troy, Wisconsin has been notified, all in Walworth County, Wisconsin, and;

**WHEREAS**, the Town Board has been given thirty days within which to comment on the proposed annexation and no comments have been received by the Village of East Troy during said thirty days, and;

**WHEREAS**, said land is contiguous to the boundaries of the Village of East Troy, Wisconsin, and;

**WHEREAS**, the Wisconsin Department of Administration has reviewed the proposed annexation and issued an opinion on July 17, 2003 finding the annexation to be in the public interest pursuant to sections 66.0217 (6) (c) (1-2), Wis. Stats. and;

**WHEREAS**, the Village of East Troy, Walworth County, Wisconsin, desires to annex said land to the Village;

**NOW THEREFORE, BE IT RESOLVED**, the Village Board of East Troy, Walworth County, Wisconsin does hereby ordain that the following described lands:

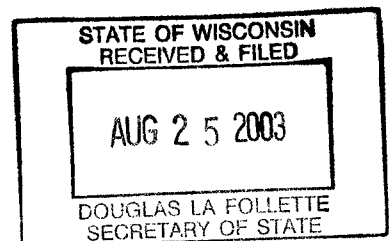
Being all of Lot 1, C.S.M. #2265 and a part of the SW 1/4 of Section 17 and the NW 1/4 of Section 20 all in T4N, R18E, Town of East Troy, Walworth County, Wisconsin.

be annexed to the Village limits of the Village of East Troy, Walworth County, Wisconsin and detached from the territory of the Township of East Troy, Walworth County, Wisconsin.

That the above described property is annexed to the Village of East Troy and temporarily zoned A-1, Agricultural Holding District.

The land shall be placed in Ward 1 of the Village of East Troy.

That attached hereto is a plat showing the boundary of the territory attached to the boundaries of the Village of East Troy, Wisconsin.




2. This ordinance shall become effective immediately upon passage by a majority of the Village Board and publication as required by law.

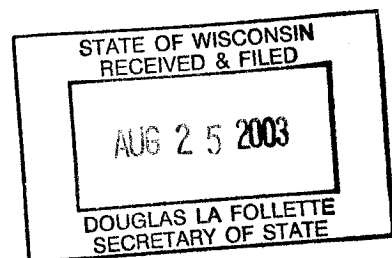

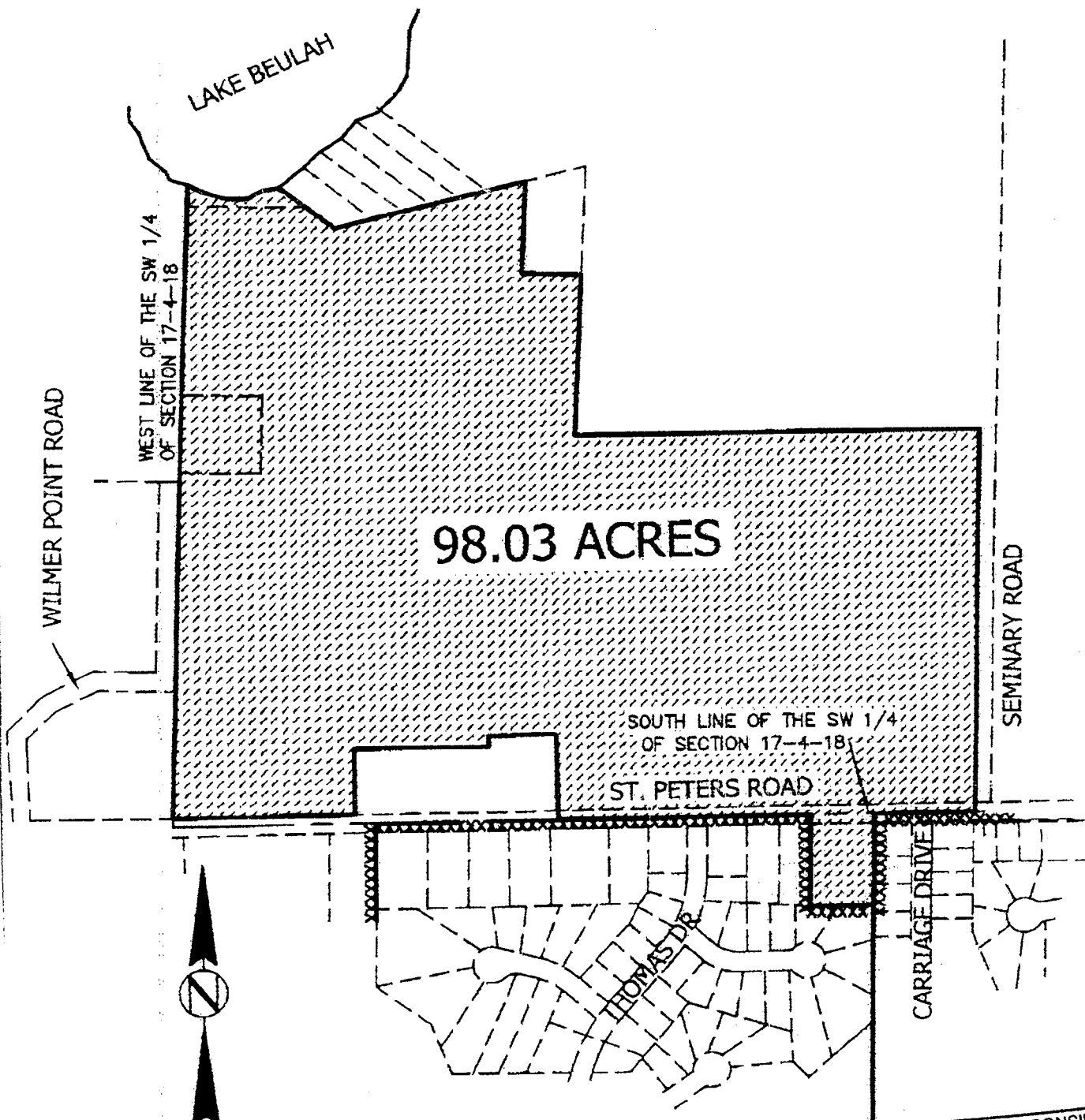

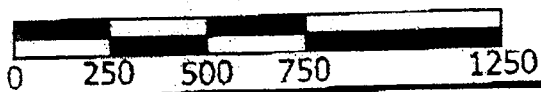
# ANNEXATION EXHIBIT
