
CHAPTER XXX OF THE ORDINANCES FOR THE CITY OF MENOMONIE FOR 2003.
An ordinance annexing territory to the City of Menomonie
THE COMMON COUNCIL OF THE CITY OF MENOMONIE DO ORDAIN AS FOLLOWS: Section 1. Chapter 21, Section LXXX is hereby created as follows:
Section LXXX Annexing Territory
(1) Territory Annexed. In accordance with Section 66.021(12), Wisconsin Statutes, the petition for direct annexation filed with the City Clerk on the 8th day of August, 2003, signed by the owner of the land in the territory, the following described territory in the Town of Menomonie, Dunn County, Wisconsin, is annexed to the City of Menomonie, Wisconsin: Part of the Southeast Quarter (SE¼) of the Northeast Quarter (NE¼) of Section Fifteen (15), Township Twenty-eight North (28), Range Thirteen West (13) Town of Menomonie, Dunn County, Wisconsin, more particularly described as follows: Commencing at the east quarter corner of said Section 15: Thence N. 00° 01' 11" E. 400.92 feet to the point of beginning; Thence S. 41° 11' 59" W. 176.56 feet; Thence S. 69° 41' 47" W. 268.10 feet; Thence S. 69° 41' 47" W. 614.68 feet; Thence S. 69° 41' 47" W. 614.68 feet; Thence 201.76 feet along the arc of a curve to the left, having a radius of 1670.00 feet, a central angle of 06° 55' 20", and a 201.64 foot chord that bears N. 23° 01' 35" W.; Thence S. 89° 49' 26" E. 286.98 feet; Thence N. 01° 04' 28" E. 1012.12 feet; Thence S. 89° 49' 26" E. 707.13 feet; Thence S. 88° 59' 05" E. 66.00 feet; Thence S. 88° 59' 05" E. 66.00 feet; Thence S. 88° 59' 05" E. 66.00 feet; Thence S. 01° 01' 11" W. 316.19 feet to the point of beginning;

(3) Ward Designation. The territory described in Section (1) of this ordinance is hereby made a part of the Second (2nd) Ward of the City of Menomonie, subject to the ordinances, rules and regulations of the City. (4) Zoning Classification. The territory annexed to the City of Menomonie by this section is designated to be part.
of the Local Commercial District of the city for zoning purposes and subject to all provisions of Chapter 18—of the Code of Ordinances for the City of Menomonie, 1975, entitled "ZONING ORDINANCE relating to—such district classification and to zoning in the City".—




