CITY OF PORT WASHINGTON OZAUKEE COUNTY, WISCONSIN ORDINANCE NO. 2003 - 18

AN ORDINANCE ANNEXING TERRITORY TO THE CITY OF PORT WASHINGTON, WISCONSIN

The Common Council of the City of Port Washington, Wisconsin, do ordain as follows:

SECTION 1. Territory Annexed. In accordance with sec. 66.0217 of the Wisconsin Statutes and the Petition for Direct Annexation filed with the City Clerk on the 7th day of November, 2003, signed by owners of at least 1/2 of the land in area in the territory (in which no electors reside), the following described territory in the Town of Grafton, Ozaukee County, Wisconsin, is annexed to the City of Port Washington, Wisconsin:

See legal description attached hereto as Exhibit A

SECTION 2. Effect of Annexation. From and after the date of this ordinance the territory described in Section 1 shall be a part of the City of Port Washington for any and all purposes provided by law, and all persons coming or residing within such territory shall be subject to all ordinances, rules and regulations governing the City of Port Washington.

SECTION 3. Temporary Zoning Classification. (a) Upon recommendation of the Plan Commission, the territory annexed to the City of Port Washington by this ordinance is temporarily zoned as follows, pursuant to sec. 66.0217(8) of the Wisconsin Statutes: AG Agricultural District

(b) As soon as practicable following annexation of the territory described in Section 1, the Plan Commission shall prepare an amendment to the zoning ordinance setting forth permanent classifications and regulations for the zoning of the annexed area and submit its recommendations to the Common Council.

SECTION 4. Ward and Aldermanic District Designation. The territory described in Section 1 of this ordinance is hereby made a part of the 4th ward and 4th aldermanic district of the City of Port Washington, subject to the ordinances, rules and regulations of the City of Port Washington governing wards.

SECTION 5. Severability. If any provision of this ordinance is invalid or unconstitutional, or if the application of this ordinance to any person or circumstances is invalid or unconstitutional, such invalidity or unconstitutionality shall not affect the other provisions or applications of this ordinance which can be given effect without the invalid or unconstitutional provision or application.


