ORDINANCE NO. MC 964 SPECIAL ORDINANCE NO. 342

A SPECIAL ORDINANCE ANNEXING TERRITORY TO THE CITY OF WISCONSIN RAPIDS, WOOD COUNTY, WISCONSIN, AND CREATING SECTION 342 OF THE CITY OF WISCONSIN RAPIDS' SPECIAL CODE OF ORDINANCES.

THE COMMON COUNCIL OF THE CITY OF WISCONSIN RAPIDS DOES ORDAIN AS FOLLOWS:

SECTION I

Territory Annexed: In accordance with Section 66.025 of the Wisconsin Statutes, the following described territory owned by the City of Wisconsin Rapids in the Town of Grand Rapids, Wood County, Wisconsin, is annexed to the City of Wisconsin Rapids:

Parts of the Northwest Quarter (NW-1/4) of the Northeast Quarter (NE-1/4); the Northeast Quarter (NE-1/4) of the Northeast Quarter (NE-1/4); the Southwest Quarter (SW-1/4) of the Northeast Quarter (NE-1/4) and the Southeast Quarter (SE-1/4) of the Northeast Quarter (NE-1/4) of Section 21, Township 22 North, Range 6 East, Town of Grand Rapids, Wood County, Wisconsin bounded and described as follows:

Commencing at the north quarter corner of said Section 21 as the point of beginning, thence N-89°-53'-52"-E along the northerly line of said Section 21, a distance of 925.60' to an iron monument; thence S-0°-09'-34"-W, a distance of 798.56' to an iron monument; thence N-89°-17'-47"-E, a distance of 360.04' to an iron monument; thence N-0°-07'-39"-E, a distance of 622.35' to an iron monument; thence S-63°-39'-33"-E, a distance of 37.99' to an iron monument; thence S-1°-42'-19"-E, a distance of 9.78' to an iron monument; thence S-63°-25'-56"-E, a distance of 34.60' to an iron monument; thence S-0°-04'-03"-W, a distance of 628.68' to an iron monument; thence S-0°-08'-47"-E, a distance of 466.26' to an iron monument; thence S-1°-27'-43"-E, a distance of 893.13 to an iron monument on the northerly line of County Trunk Highway "W"; thence N-70°-08'-55"-W along the highway right-of-way line a distance of 1439.27' to an iron monument on the westerly line of the said SW-1/4 of the NE-1/4 thence N-0°-40'-58"-W along the westerly line of the SW-1/4 of the NE-1/4 a distance of 399.60' to an iron monument; thence N-0°-38'-46"-W along the westerly line of the NW-1/4 of the NE-1/4 a distance of 1311.79' to an iron monument to the POINT OF BEGINNING and containing approximately 53.40 acres of vacant land.



SECTION II

Effect of Annexation: From and after the adoption date of this ordinance, the territory described in Section I shall be a part of the City of Wisconsin Rapids for any and all purposes provided by law and all persons coming or residing within such territory shall be subject to all ordinances, rules, and regulations governing the City of Wisconsin Rapids.

SECTION III

Ward Designation: The territory described in Section I of this ordinance is hereby designated a part of the 15th ward of the City of Wisconsin Rapids, subject to the ordinances, rules, and regulations of the city governing wards.

SECTION IV

Zoning: The territory being annexed to the City of Wisconsin Rapids shall become a part of the residential zoning district.

SECTION V

Severability. If any provision of this ordinance is invalid or unconstitutional, or if the application of this ordinance to any person or circumstance is invalid or unconstitutional, such invalidity or unconstitutionality shall not affect the other provisions or application of this ordinance which can be given effect without the invalid or unconstitutional provisions or application.

SECTION VI

Effective Date: This ordinance shall take effect upon passage and publication as provided by law.


