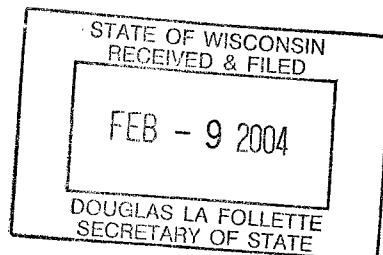

ORDINANCE NO. 04- 01

ORDINANCE RELATIVE TO ANNEXING TERRITORY TO THE VILLAGE OF CAMBRIA:

The Village Board of the Cambria does hereby ordain as follows:

Section 1. Territory Annexed.

In accordance with Sec. 66.0217 of the Wisconsin Statutes and the petition for direct annexation filed with the Village Clerk on the 5th day of January, 2004, signed by all the owners of all the land and real property in the following described territory of the Town of Courtland, Columbia County, Wisconsin, said territory is annexed to the Village of Cambria, Wisconsin:

SEE LEGAL DESCRIPTION ATTACHED:

Section 2. Effect of Annexation.

From and after the date of this Ordinance the territory described in Section 1 shall be a part of the Village of Cambria for any and all purposes provided by law and all persons coming or residing within such territory shall be subject to all Ordinances, rules and regulations governing the Village of Cambria.

Section 3. Temporary Zoning Classification.

(a) Upon recommendation of the Plan Commission, the territory annexed to the Village of Cambria by this Ordinance is temporarily zoned as follows, pursuant to Sec. 66.021(8)(a) of the Wisconsin Statutes: R-1, Residential.

(b) The Plan Commission is directed to prepare an amendment to the Zoning Ordinance setting forth permanent classifications and regulations for the zoning of the annexed area and to submit its recommendations to the Village Board.

Section 4. Severability.

If any provision of this Ordinance is invalid or unconstitutional or if the application of this Ordinance to any person or circumstances is invalid or unconstitutional, such invalidity or unconstitutionality shall not affect the other provisions or applications of this Ordinance which can be given effect without the invalid or unconstitutional provision or application.


Section 5. Effective Date.

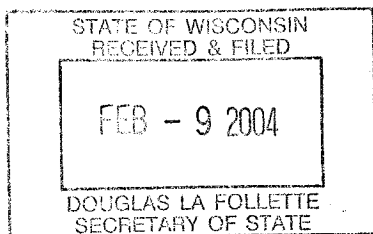
This Ordinance shall take effect upon passage and publication and publication as provided by law.

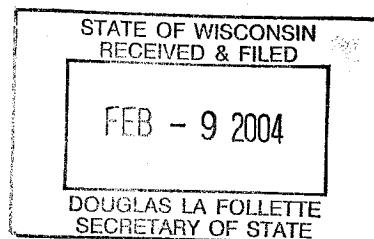

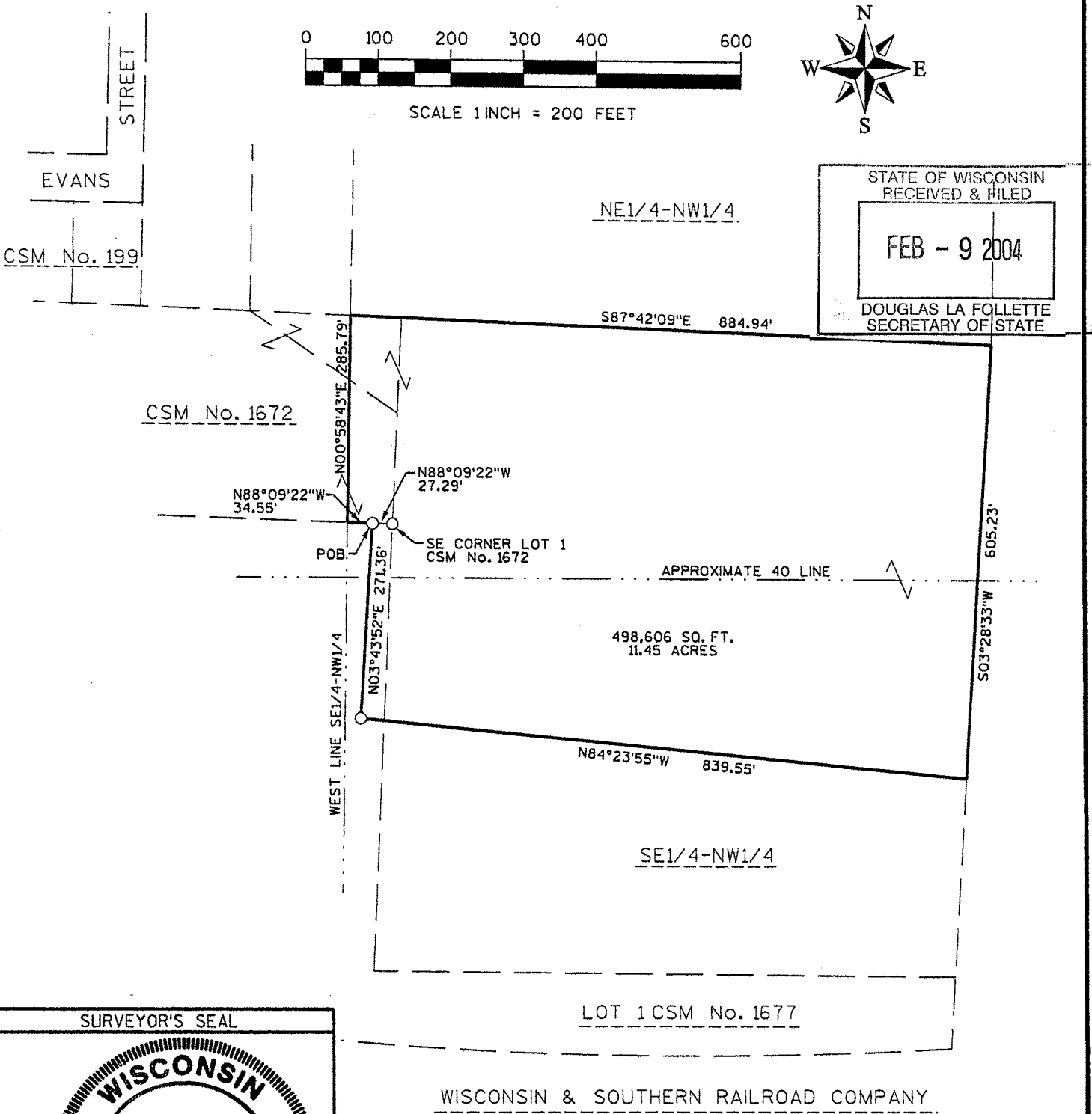

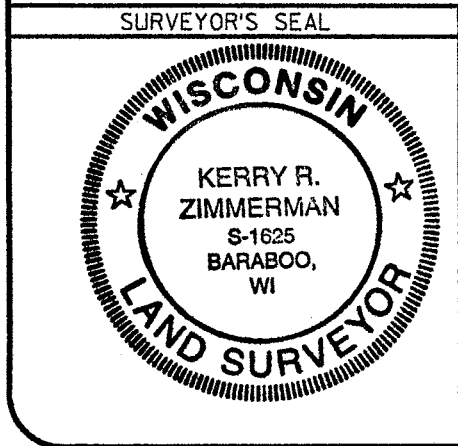
