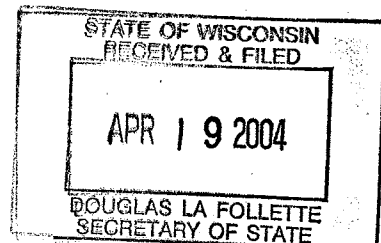

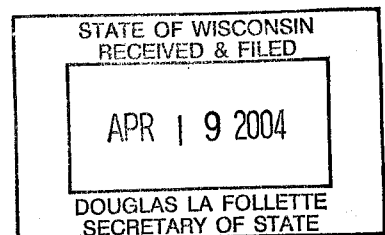
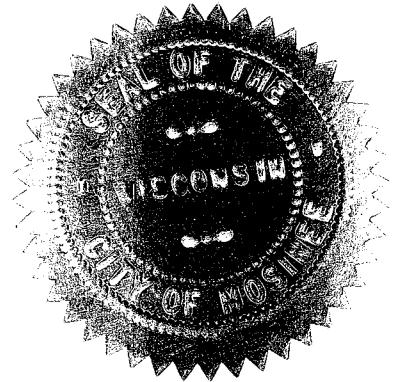

## Ordinance No. 2004-02

### AN ORDINANCE ANNEXING AND ZONING TERRITORY TO THE CITY OF MOSINEE, WISCONSIN

Whereas, the City of Mosinee, Marathon County, Wisconsin has received a petition seeking the annexation and zoning of certain property located in Marathon County, Wisconsin, to the City of Mosinee; and

Whereas, the petition received by the City is a petition for direct annexation and the petition meets the requirements of Section 66.0217 of the Wisconsin Statutes to allow for the annexation of property by unanimous consent; and

Whereas, the City of Mosinee Plan Commission has held a Public Hearing and reviewed the request to zone the territory to be annexed into the City; and

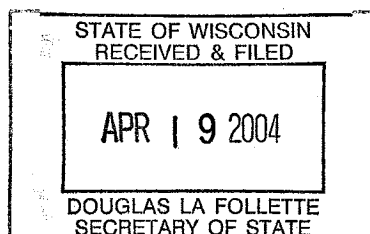
Whereas, the City has determined that the annexation and zoning of the territory, will promote sound planning and growth of the City, and otherwise enhance and promote the general welfare of the City and its residents.

NOW, THEREFORE, the Common Council of the City of Mosinee, Wisconsin does hereby ordain as follows:

1. **Territory Annexed.** In accordance with section 66.0217 of the Wisconsin Statutes and the petition for direct annexation filed with the City Clerk on the 25<sup>th</sup> day of October, 2003 by Stuart A. Carlson on behalf of the Wausau Mosinee Paper Corporation, signed by all of the electors residing in the territory and the owners of all of the land in the territory to be annexed, the following described territory in Marathon County, Wisconsin, is hereby annexed to the City of Mosinee, Wisconsin:

*Government Lots Six (6), Seven (7) and Eight (8) of Section 20, Township 27 North, Range 7 East of Marathon County, Wisconsin.*

2. **Zoning Classification.** The territory annexed to the City of Mosinee by this ordinance is zoned as follows: R-5 Agricultural & Estate District. The official zoning map for the City of Mosinee shall be amended to reflect the zoning designation for the annexed territory.
3. **Ward Designation.** The territory described in Section 1 of this ordinance is hereby made a part of the Sixth Ward of the City of Mosinee, subject to the ordinances, rules and regulations of the City of Mosinee governing wards.



4. Effect of Annexation. From and after the date of this ordinance, the territory described in section 1 shall be a part of the City of Mosinee for any and all purposes provided by law and all persons coming or residing within such territory shall be subject to all ordinances, rules and regulations governing the City of Mosinee.

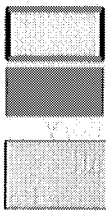
