

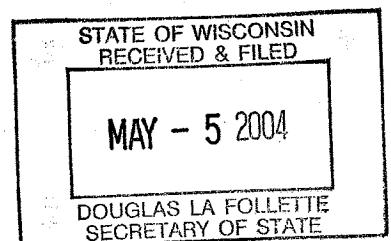

ORDINANCE # 04-03

AN ORDINANCE TO ANNEX REAL ESTATE LOCATED IN THE TOWN OF WAUPUN TO THE CITY OF WAUPUN.

THE COMMON COUNCIL OF THE CITY OF WAUPUN, DO ORDAIN:

SECTION 1: The following real estate, owned by the City of Waupun, is detached from the Township of Waupun and annexed to the City of Waupun:

The South 100 feet of the West 555 feet of the West One-Half (W ½) of the Southwest Quarter (SW 1/4) of the Southwest Quarter (SW 1/4) in Section 29, Township 14 North, Range 15 East, Town of Waupun, Fond du Lac County, Wisconsin.

Also the South 100 feet of the East One-Half (E ½) of the Southeast Quarter (SE 1/4) of the Southeast Quarter excluding the West 55 feet thereof; Lying in Section 29, Township 14 North, Range 15 East, Town of Waupun, Fond du Lac County, Wisconsin.

SECTION 2: The real estate shall be zoned C- Conservancy District for zoning purposes until the zoning map may otherwise be amended.

SECTION 3: The real estate shall be placed in the 5th Aldermanic District.

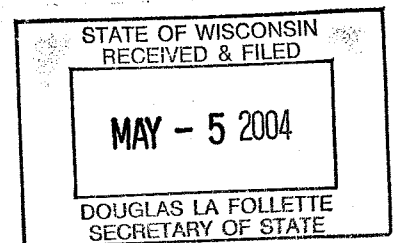
SECTION 4: This Ordinance shall be in full force and effect on its passage and publication as provided by law.

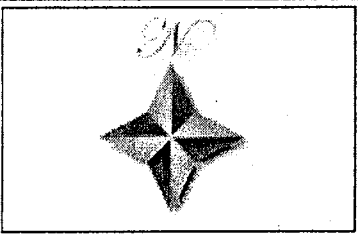
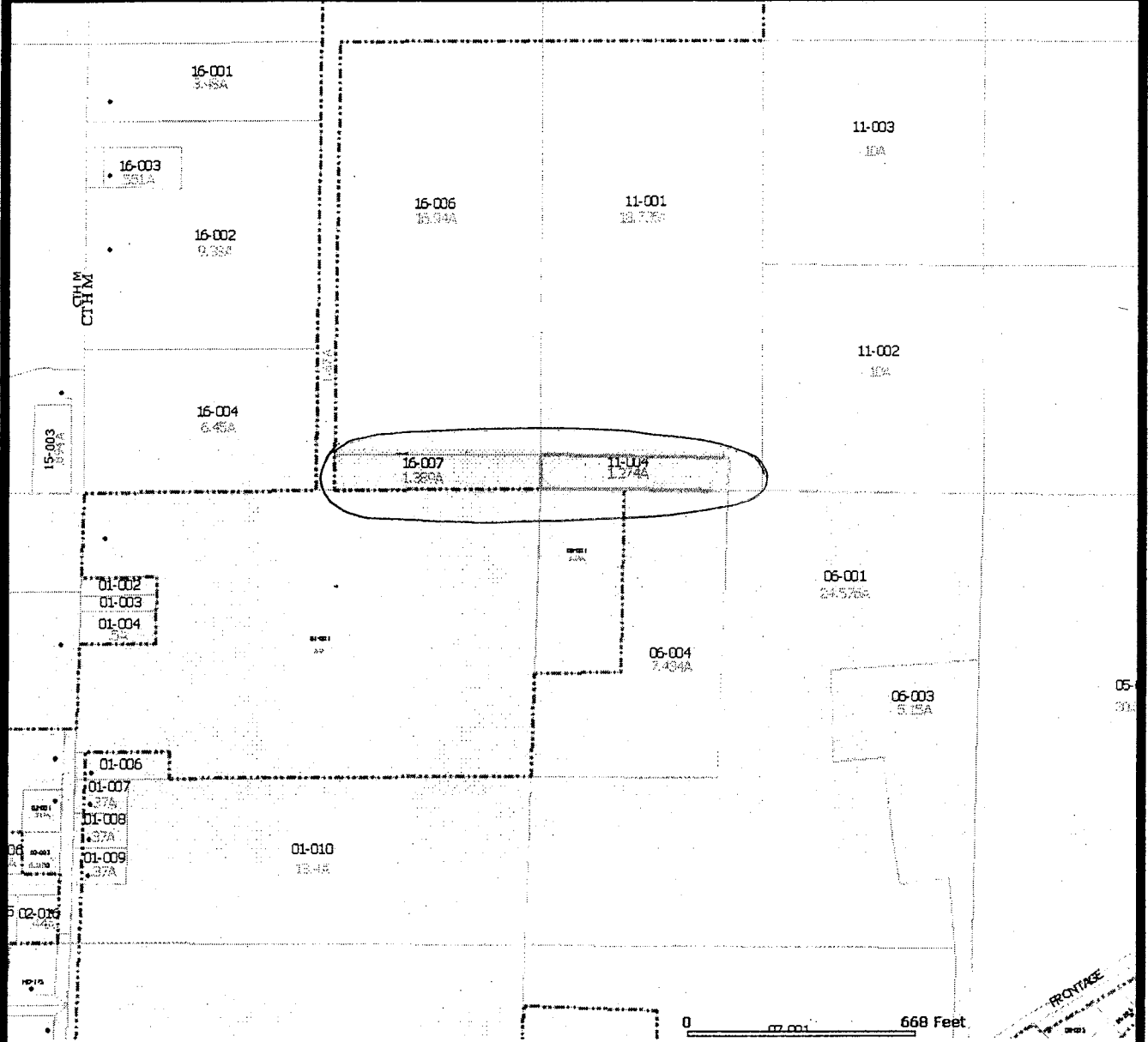
